Alcohol Dependence

Yaniv tells doctors he doesn't drink, while telling friends that he drinks to excess even when taking medication that prohibits alcohol.

- shows teen viewers on Snapchat how to mix spiced rum with Gummi bears (MM.org [article](#), 9/6/20)
- neighbor reports seeing Yaniv drunk at 9:30 a.m. ([archived tweet](#), 5/3/20)
- drunken videos proliferating (KF post [4,725](#), 5/2/20)
- Snapchat conversation with 16-year-old shows his collection of more than 40 wine and liquor bottles (MeowMix [archive](#), 4/19/20)
- one of Yaniv's neighbors reports seeing him disposing of lots of empty liquor bottles ([archive](#), 4/3/20)
- says he likes taking Midol with wine; asked if he gets high from it, he says yes; says he takes two tablets; Midol contains acetaminophen, caffeine, and pyrilamine maleate (an antihistamine) (p. 182, [MM transcript](#); KF thread, 11/26/19); drinking alcohol with acetaminophen can increase the risk of liver damage
- "I'm stressed and when I get stressed... :/" and "I'm drunk right now and I feel sick" (p. 166, [MM transcript](#), 11/26/19)
- "I have so much booze here" on 11/19/19 (p. 217, [MM transcript](#), 11/26/19)
- "I drank too much last night holy fuck it screwed with my meds" on 11/15/19 (p. 200, [MM transcript](#), 11/26/19); says "I'm on heavy medication" on 11/8/19 (p. 173) and on 11/9/19 that he takes medication for pain (p. 177) ([MM transcript](#); KF [thread](#), 11/26/19)
- "I had so much baileys last night omg" on 11/11/19 (p. 186, [MM transcript](#), 11/26/19)
- says he's drinking but shouldn't on 10/28/19 (p. 139, [MM transcript](#), 11/26/19)
- was drinking at Rogue Wetbar on 9/14/19 until the manager asked him to leave because women customers objected to his presence (p. 2, [MM transcript](#), 11/26/19)
- tells Katie he sent her a selfish message about expecting him to support him pre- and post-GRS because he "started drinking" and then wrote it while hung over (MM.org, [Katie/JY screen shots](#), 11/6/19)
- "Lol i'm drunk..." (p. 140, [MM transcript](#), 10/28/19)
- tells online doctor that he's not using alcohol, drugs, or caffeine ([CoR](#), 8/28/19)
- posts on KF, "im soooooo drunk holy shhittttttititi" (MM.org, [WgKittyLangleyRes43](#), 8/8/19)
- said he was drunk when he posted threats and porn on KF (KF [thread](#), 8/9/19)
- tells online doctor that he does not "partake" of alcohol ([CoR](#), 4/30/19 p.m.)
- tells online doctor that he's worried about elevated Gamma GT level of 47; says he's a non-drinker (common causes of elevated GGT are obesity and alcoholism) ([CoR](#), 4/12/19)

Allergies

Yaniv says he has several allergies, but one at least - seafood - has been disproven by medical testing.

Gluten

- tweets at a restaurant complaining that the flatbread he ate tasted like burned cardboard; when someone asks about his gluten allergy, he responds, "Sometimes a girl has got to eat even when it makes me fart" (KF post [1792](#), 10/9/19)
- celebrated his release from an emergency room for the second time in two days by ordering "Timbits" doughnut holes at Tim Horton's, makes selfies in his tiara and evening gown (KF post, [5/23/19](#))
- ate gluten, reported cramping and diarrhea to online doctor (CoR, [5/7/19](#))
- says he is allergic to gluten (KF post, [4/29/19](#))

Seafood

- tells Sara on 7/11/20 he's deathly allergic to all "shellfish, fish and seafood" despite having had test results that say otherwise (see entry below) (MM.org, [Chunk 3](#), 9/11/20)
- asks online doctor to renew his epipen prescription because he gets anaphylaxis with seafood; had allergy testing done 2 weeks ago via referral from his former GP and learned he was no longer allergic to seafood, has never had full anaphylactic reaction because he avoids seafood (CoR, [8/28/19](#))
- oil in which fish has been fried, but not oil in which chicken has been fried (KF post, [5/13/19](#) re: his complaint tweeted at McDonald's)
- DM'd a woman on 12/2/14 that he has "a life threatening allergy to seafood, like if I eat it, I die" and was fearing the worst after eating a "small small small bit of tuna in this salsa at costco" (KF thread, [11/13/19](#))

Other Types of Food

- tells online doctor he's dizzy and felt that way two days ago, too; thinks it's food related, ated honey garlic chicken from a grocery store this morning and felt all right afterward but now feels sick, has appointment with GP tomorrow (CoR, [4/9/19](#))
- tells online doctor he's had an allergic reaction to fast food, became woozy, itching, pain in side of neck; told it may not be an allergy but it wouldn't hurt to take an antihistamine; requests more allergy tests and is told to ask family doctor; also requested an extra epipen (CoR, [4/3/19](#))

Chlorine

- DM'd a woman on 6/13/14 that his skin is so sensitive to pool chlorine that he wants to wear a woman's one-piece bathing suit to protect himself; she points out a suit won't help but he persists in pestering her for suit-buying advice and sends her a pic of himself in his new suit (KF thread, [11/13/19](#))

Cats (KF post, [5/31/19](#))

Audiology

Yaniv's mother, Miriam, and aunt have long had hearing impairments as a result of mitochondrial disease. In 2019, he himself began wearing hearing aids and in August 2020 he said in a court filing that he's hearing impaired. See also Genetic.

- selfie shows what turns out to be the clear plastic grip of a HearGlow hearing aid in his ear (KF [5,675+](#), 10/10/20)
- tells Sara he wears hearing aids and gets his hearing tested nearly every 2 months (MM.org, [Chunk 5](#), 9/17/20)
- tells his strata in August to install a fire alarm strobe light in his unit (August correspondence list, [archived tweet](#), 10/3/20)
- states in another court filing - one brought against his neighbors in 401 regarding water damage after an August 2020 fire - that he's hearing impaired (MM.org [article](#), 9/2/20)
- is hearing impaired, according to a civil complaint he filed against the Town of Langley regarding his arrest and brief confinement in August 2019 after displaying an illegal stun gun on a stream with Blaire White (MM [article](#), 8/27/20)
- says his hearing aids aren't working ([tweet](#), [archived tweet](#), showing text exchanged with RCMP, 8/18/20)
- texts Sara while he's in Toronto on 7/18/20, regarding a voicemail he received, "One of my hearing aids died so I'm having a bit of issues hearing you" (MM.org, [Chunk 4](#), 9/11/20)
- messages Katie on 11/4/19 that his neurologist's office called to say his Dx wasn't correct, his condition may be worse, and "there's no explanation why I lost my hearing" ([slide](#), KF [thread](#), 11/17/19)
- tells online doctor hearing test 2 weeks ago found he had 50% hearing loss in both ears, Yaniv tells online doctor ([CoR](#), 7/12/19); online doctor notes Yaniv is wearing hearing aids on both ears ([CoR](#), 9/11/19)
- Jonathan and Miriam give a hearing aid center positive reviews on 2/4/2016; Miriam's been a customer for 7 years; Yaniv says that he has known the tech for years ([KF post](#), 12/31/18)
- blogged on trustednerd.com that he used a hearing aid on a flight to Vegas, although "I don't have much of a hearing impairment, yet" ([archive.fo](#), 6/19/16)
- Carlee had lunch with Yaniv, his mother, and his Aunt Ilana in 2015 and reported that Miriam used hearing aids and Ilana communicated solely through sign language (MM.org [article](#), 11/27/20)
- told a girl he was messaging in 2014 that his hearing is deteriorating (MM.org, [Madison8](#); KF post [196](#), 1/17/20)

Cancer

Yaniv dramatized a series of cancer scares in 2019. He was found to have a non-cancerous skin condition, breast sensitivity due to synthetic hormone use, and an arachnoid cyst in his cerebellum that neurologists and

a neurosurgeon have not believed requires immediate surgery. See Dermatology, Sexuality - Female, and Neurology for details.

Skin

- [biopsy](#), not skin cancer, 2019
- [wound separation](#) after biopsy

Breast

- tells Sara his maternal aunt had a mastectomy on 1/30/13, which adds to the list of medical treatments he observed in his family and later claimed to need (MM.org, [Chunk 3](#), 9/11/20)
- having right breast pain since March 2019; has felt no lumps; requests and gets referral to a gynecologist; had ultrasound of breast one month ago; online doctor observes no skin puckering or redness via video cam ([CoR](#), 7/22/19)
- goes for breast exams every two weeks, according to Katie (KF [thread](#), 11/17/19)
- tweets hospital "mammo" unit sign and says, "This is more serious than they told me initially," three weeks after saying no tumors were found in his chest ([KF post](#), 7/2/19)
- surprised a mammogram hurt so much, has referral for a pap smear ([KF post](#), 6/14/19)
- says he's doing "breast cancer testing" and is afraid "something" has been found in brain and breast ([KF post](#), [KF post 2](#), 6/12/19), only to say the same day, "Clear! No cancers or tumors!" ([KF post](#), 6/12/19)
- tells online doctor he went to a walk-in clinic for pain in his right breast, doctor could feel lump, will have ultrasound later today ([CoR](#), 6/11/19)
- messages Nicole, "I may have breast cancer" (MM.org, [Nicole138](#), 6/10/19)
- since Estradiol dose was increased a couple of months ago from 2mg to 4mg/day, has had intermittent pain in right breast; aunt and grandmother had breast cancer; no redness, lump or other symptoms ([CoR](#), 3/22/19 p.m.)

Lung

- tells Katie on 10/30/19 that his father died of lung cancer because the doctor didn't take the symptoms seriously soon enough (KF [thread](#), 11/17/19)
- says he had a "test" for cancer in his chest, breasts, and brain and is 100% sure "something bad is there" ([KF post](#), 6/12/19)
- says "Clear! No cancers or tumors!" same day that he announced testing ([KF post](#), 6/12/19)

Brain

- tells Sara on 7/16/20 that his father had brain surgery when Jonathan was 10, meaning 1997 (MM.org, [Chunk 4](#), 9/11/20)
- tells online doctor that a neurosurgeon does not believe surgery to remove arachnoid cyst is necessary but will see Yaniv in a year to reassure him; legs numb, falls frequently, pain in left posterior area of head ([CoR](#), 7/8/19)

- asks online doctor for a referral to another neurologist; has numbness in both legs below waist, has to use walker; no falls so far; Dr. A. Lee, neurologist says the arachnoid cyst is life threatening ([CoR](#), 7/7/19)
- tells online doctor that it's a year's wait to see neurosurgeon ([CoR](#), 7/2/19)
- Null's source says Yaniv does not have any cancer, it's an issue with his filtering organs allowing excess fluid to collect in his skull ([hydrocephalus](#)) and needing a way to drain it ([7/3/19 stream](#) around the 55-min. mark; [KF post](#), 7/2/19 refers to it but contains slight wording error); Dx questioned by medical historian (KF post [8](#), 7/24/19)
- hospital report says he has a particular type of arachnoid cyst known as a Blake's cyst in his cerebellum, growing and pushing on the 3rd and 4th ventricles, referred for surgery; cyst is impairing cognitive and motor abilities, eye's twitching, can't walk straight ([CoR](#), 6/17/19)
- says he's afraid "something" has been found in brain and breast ([KF post](#), [KF post 2](#), 6/12/19) then says on the same day, "Clear! No cancers or tumors!" ([KF post](#), 6/12/19)

Cardiology

- asks online doctor to order an ECG to make sure everything's ok because he hasn't had one in about 5 years (results were fine then) ([CoR](#), 3/20/19)

Dermatology

- has the mole underneath his nose removed on 8/21/20 (MM.org, [Chunk 8](#), 9/17/20); on 8/22 he tells Sara in a weepy video that the surgical site hurts like hell, but he may just be trying to avoid discussion of his finances (MM.org, [Chunk 9](#), 9/20/20)
- tells Sara he goes for 5-minute tanning booth treatments against his doctor's advice (MM.org, [Chunk 6](#), 9/17/20)
- image of the top of his head may show the presence of lice ([archived tweet](#), 9/7/20)
- Nicole scolds him for wanting to get a piercing and tattoo despite the pandemic and his being in the high-risk health category (MM.org, [Nicole41](#), 4/21/20)
- tweets that he has [acanthosis nigricans](#), which causes dark, velvety patches of skin to appear in armpits, groin, and neck, typically in people who are obese or diabetic, but can be a sign of a cancerous tumor in an internal organ, such as the stomach or liver (KF post [1585](#), 9/29/19; KF post [2,953](#), 12/13/19). May have been part of the cancer scare earlier in 2019 - see above.
- online doctor notes Yaniv has acanthosis nigricans in his armpits ([CoR](#), 9/11/19)
- itching all night all over; online doctor says pruritus can be caused by estradiol and reducing dose may help ([CoR](#), 4/17/19)
- tells online doctor he has a bump behind his ear that is painful; popped it once in the past and it released clear fluid; told it's probably an infected cyst that will require surgical drainage ([CoR](#), 3/28/19)

- he tells online doctor that he has had an Infected sore on side for the last 12 days and posts photograph; doctor says it looks like an open infected wound with a small amount of surrounding infection; told that since he's already on antibiotics he should use a topical cream on the wound ([CoR](#), 3/22/19)
- tells Carlee on 6/4/15 the he has folliculitis [sic] which gives him such bad rashes he cannot walk or drive at times and that cysts form on his inner thighs that require him to have steroid injections; doctor tells him to bathe frequently with bleach but he does it far less frequently because he doesn't like it ([MM article](#), 11/27/20)
- tells Carlee on 5/31/15 that he has white dots ([millia](#)) under his eyes and his boss chides him for looking tired because of it, saying he looks like a raccoon ([MM article](#), 11/27/20); he will tell Sara about it in 2020, too (MM.org, [chat log](#), p. 20)
- told a 17-year-old known as "M" or "Madison" in 2014 (or 2015?) that he has "folliculitis" ([folliculitis](#), usually caused by a bacterial or fungal infection); a doctor told him to [bathe with bleach](#) (KF post [196](#), 1/17/20; MM.org, [Madison8](#))

Diabetes, Obesity, Eating Problems

Yaniv has been diagnosed with type 2 diabetes and obesity, but continues eating destructively and has both underdosed and overdosed on the Rx'd meds. Some of the symptoms he's ascribed to neurological problems, including brain cancer and epilepsy, appear to stem from his uncontrolled diabetes. On 7/12/19, he said he was 5'11" and 255 lbs (BMI 35.6; obesity is 30 or greater) and appears to have gained weight since then. On 9/11/19, he gave his height as 6'0" and his weight as 125kg (276 lbs), giving him a BMI of 37.4.

- failed to make girls' swim team due to weight and slowness (Twitter, [archive](#), 11/7/20)
- tells Sara on 9/4/20, "I think my blood sugar is low" (MM.org, [Chunk 11](#), 9/20/20); neighbor observed paramedics being buzzed in and Miriam arriving with a box of iced tea; paramedics leave without Yaniv ([tweet](#); [archived tweet](#)); tells Sara the paramedics couldn't tell what was wrong, his doctor sent him for blood tests, doctor said it might have been a "hormonal blip" (MM.org, [Chunk 11](#), 9/20/20)
- texts Sara on 7/27/20, "I forget to drink [water] then I get woozy and collapse. If it gets really bad I go into a store and get pedalyte" [Pedialyte] (MM.org, [Chunk 4](#), 9/11/20)
- tells Sara on 7/9/20 that "my blood sugar is having issues today and I'm a bit woozy" so he gave up plans to go check out engagement rings; then says "Yeah I have type 2 diabetes, but it's getting better," says his A1C is "like 6.2" (MM.org, [Chunk 3](#), 9/11/20)
- tells Sara on 6/8/20 that he pees "A LOT," which he attributes to the synthetic hormones he takes rather than to having uncontrolled Type 2 diabetes (MM.org, [Chunk 2](#), 9/11/20)
- tells Sara on 5/31/20 that he's drinking a Dairy Queen strawberry shortcake blizzard brought by DoorDash, a bev with 97 grams of sugar in it and zero nutrients (MM.org, [Chunk 1](#), 9/11/20)
- says he's diabetic in a civil complaint filed against the town of Langley and was denied his meds during the (short) period of confinement during the August 2019 booking process after he displayed an illegal stun gun on a stream with Blaire White (MM.org [article](#), 8/26/20)
- fat shames strata neighbor (MM.org [article](#), 6/23/20)
- diabetes Type 2 bracelet observed on his wrist during 11/7/19 makeup videos ([KF post](#), 11/8/19)

- on 11/2/19, "I'm not eating again" ([MM transcript](#), p. 153, [KF thread](#), 11/26/19)
- dined at restaurant on 10/26 but on 10/27 says "I'm not eating again" ([MM transcript](#), pp. 126, 127, [KF thread](#), 11/26/19)
- on 10/24/19 says on several occasions that he cannot eat but soon thereafter reports eating pasta, nachos, or candy and drinking wine or Bailey's ([MM transcript](#), p. 117, [KF thread](#), 11/26/19)
- online doctor recaps with Yaniv:
 - he was in ER 2 days ago with whole-body twitching but no loss of consciousness; blood work was normal, main abnormality was high blood sugar; pattern consistent with type II diabetes; appointment at diabetes clinic on 8/1; taking Metformin only once a day instead of twice as Rx'd, EEG upcoming ([CoR](#), 7/15/19)
 - this ER trip may have been the incident after which Yaniv posted pictures of his feet against the doors of an ambulance on Facebook, saying, "My dog is dying and I'm an emotional wreck. Life has been horrible to me lately. I don't know how much more I can take on top of these major unsolvable health issues"; but neighbor observed no ambulance at Yaniv's condo building that night ([KF post](#), 7/14/19)
- tells online doctor that he had his first B12 shot yesterday and feels better, needs replacement vial because he lost the one he was given ([CoR](#), 7/12/19)
- gives his weight as 255, height as 5'11" to online doctor, which is a BMI of 35.6; two months later he gives his weight as 125kg (276 lbs) and his height as 6'0", which is a BMI of 37.4 ([CoR](#), 9/11/19); the obese category begins with a BMI of 30
- tells online doctor he went to Surrey Hospital early in the morning feeling faint, blood work normal except for an [increased CRP](#) of 8; does not recall ever being told he has diabetes, 7/10 blood work shows fasting blood sugar was high at 9.9 and B12 was low at 141; he recently stopped taking the supplements he was told to take, inc. B complex vitamin; says he's not been vegan or vegetarian; referred to endocrinologist and for B12 injections, booked for EEG ([CoR](#), 7/11/19)
- tells online doctor that yesterday he lost feeling from neck down while sitting in car, lasted about 3 minutes, rushed into a Subway sandwich shop, ate, and then felt better, had no glucose strips so could not test ([CoR](#), 7/2/19)
- says he has had an NFC microchip implanted ([KF post](#), 6/5/19); posts photo of a Freestyle Libre glucose monitoring system disc on his upper arm ([KF post](#), 6/26/19); disc identified ([KF post](#), 6/26/19)
- Saxenda not on meds list he posts on 6/4/19 - no longer Rx'd for it? ([KF post](#))
- complains blood sugar may have dropped "super low" again ([KF post](#), 6/1/19)
- says he has an eating disorder and vomits after eating (does not say he induces vomiting as a bulimic does), eats once a day, wastes \$100s on food he will never eat ([KF post](#), 5/29/19)
- ambulance trip, posts "these meds have done so much damage" ([KF post](#), 5/23/19)
- overdosed on Saxenda on 5/20/19
 - [he messages on FB](#) that he's injecting [Saxenda](#) to lose weight; in ambulance video, says he was [using too much](#)
 - posts two FB videos about having accidentally taken 5xs the Saxenda he should take; in both he says he's fine, asks people to text him, giggles; in one he's making the video from inside an ambulance (MeowTube [Medical 03](#), [Medical 04](#))

- tells online doctor on 5/21/19 that he started Saxenda 6 days before, 0.6mg dose, but injected 3.0mg by mistake on 5/20/19 at 4 p.m.; taken to ER by ambulance, blood sugar readings were never in true hypoglycemic range, but 24 hours later he's still having nausea and acid reflux; told it may be 1-3 days before effects wear off. Told to stop loading up on sugar. ([CoR](#), 5/21/19)
- later tweeted that the Saxenda OD was deliberate and intended to be fatal ([KF post](#)); repeats that assertion ([KF post](#), 5/28/19)
- online doctor refers him to dietician, recommending paleo or Mediterranean diet and exercise; "Our impression was: Obesity" ([CoR](#), 5/20/19)
- tells online doctor he was Dx'd with pre-diabetes with an A1C of 6.7; told diabetes starts at 6.5 and he's on daily Metformin and Saxenda to treat it; wants and gets glucose monitor ([CoR](#), 5/17/19)
- tells online doctor he's taking a higher Metformin dose and wants to know if it can cause hot flashes ([CoR](#), 5/3/19)
- blood work shows low B12 level, says he eats red meat a few times a week (despite saying on 4/13 that he's vegan) and also "a lot of veggies," does not take supplements; told to start taking a complex B vitamin ([CoR](#), 5/1/19)
- wants A1C tested monthly, online doctor says no, it's done every 3 months; complains of dizziness, doctor says it resolves when Yaniv eats something and he's never actually passed out ([CoR](#), 4/16/19)
- blood glucose was 6.6, A1C 6.5, and cholesterol 6,29/3,82/11,0/3,0, Gamma GT 47; taking Metformin for diabetes; tells online doctor he's "pretty active" and has switched to vegan diet ([CoR](#), 4/13/19)
- tells online doctor that he's worried about elevated Gamma GT level of 47; says he's a non-drinker (common causes of elevated GGT are obesity and alcoholism) ([CoR](#), 4/12/19)
- tells online doctor that his ferritin level is high; is told that can be caused by diabetes, be a side effect of certain medication, or be caused by consuming too much iron, so see family doctor ([CoR](#), 4/11/19)
- type 2 diabetes makes [waxing inadvisable](#)

Facial Injuries/Surgery

- neighbor notices Yaniv has had the large growth beneath his nose removed ([archived tweet](#), 8/27/20)
- someone on Twitter claims Yaniv was punched by a 60+ woman who yelled at Miriam for laying on the horn in a parking area (archived [tweets](#), 7/21/19)
- says the police forced him to go to the ER because of swelling on his face ([KF post](#) 7/19/19), posts small excerpt from a hospital form that says "ASS ASSAULTED" ([KF post](#), 7/19/19); says he was punched ([KF post](#), 7/20/19)

Gastrointestinal

Yaniv has long suffered from gut pain and as early as 2008 was saying stomach problems caused rectal bleeding. He now refers to his gastrointestinal problems as menstrual periods. He also says he has reflux. People who encounter him IRL report he seems to have urinary and fecal incontinence.

- though KF rated a past allegation that he wears diapers “[fake and gay](#)” because the person claiming knowledge of it refused to verify themselves, a neighbor provided a photo of him looking as though he had a load in his pants and said there was a strong smell of feces when in the elevator with him (Twitter [archive](#)); on 12/1/20, a caregiver noted the seams showing through his shorts in the pic were consistent with an adult diaper (Twitter [archive](#)), while another neighbor saw him getting out of car with a wet crotch, possibly indicating incontinence (Twitter [archive](#)), that is, the diapers may reflect a medical problem rather than a fetish
- tells Sara on 6/15/20 that stress in high school and college caused him to have ulcers that bled, leading him to wear pants to catch the blood; hospital testing required him to drink barium every few months (MM.org [Chunk 2](#), 9/11/20)
- tells Nicole his doctor wanted him to go to the ER for pain but he doesn’t want to; does go but “I walked out. There not putting a fucking tube down my throat” (MM.org, [Nicole40-42](#), 4/19/20); was this a respiratory? or was he in for a GI because of stomach pain complaints?
- complains frequently about gut pain, claiming it’s menstrual cramps (examples: [KF post](#), 10/13/19; [KF post](#), [tweet](#), 5/26/19; [KF post](#), 5/26/19); mother says under oath that he has had abdominal cramping all his life ([KF post](#), 7/16/19); she repeats that testimony the following day ([notes](#), 7/17/19)
- tells MandaPanda on 10/8/19, “I’ve got tons of gas” (p. 52, [MM transcript](#); [KF thread](#), 11/26/19)
- “Omg these stomach aches” on 11/19/19 (p. 217, [MM transcript](#); [KF thread](#), 11/26/19)
- tweets at a restaurant complaining that the flatbread he ate tasted like burned cardboard; when someone asks about his gluten allergy, he responds, “Sometimes a girl has got to eat even when it makes me fart” (10/9/19, [KF post 1792](#))
- tells online doctor he has stuffy nose and has vomited a few times, wants antibiotics; doctor says it sounds viral and antibiotics won’t help, suggests home remedies ([CoR](#), 6/7/19)
- tells online doctor he has [reflux](#) ([CoR](#), 5/14/19)
- ate gluten, reported having cramping and diarrhea to online doctor ([CoR](#), 5/7/19)
- tells online doctor that he’s been vomiting after eating for 7 to 10 days, diarrhea began yesterday, fever, body aches; told it’s likely gastroduodenitis, a viral infection, avoid dairy for a few weeks, eat simple, nourishing food and hydrate ([CoR](#), 4/12/19); on 3/30 he reported flu-like symptoms after getting flu shot, including vomiting, then on 4/3 and 4/9 he reported feeling dizzy and sick, but no vomiting and reported other problems in other sessions without mentioning vomiting
- attributes rectal bleeding to an unspecified stomach problem in 2008 chats (KF [chatlog](#), 7/25/08)

Genetic

Yaniv's mother, Miriam, and her sister have been treated for mitochondrial disease for at least two decades ([KF post](#); <https://archive.li/yJiKd>). The term includes a variety of hereditary genetic mutations in the mitochondrial DNA that can lead to seizures, hearing loss, heart problems, and respiratory failure. In 2019, Yaniv began seeking a referral for assessment at the Complex Chronic Diseases Program at BC's Women's Hospital where Miriam and her sister have been treated. In 2020, he tells Sara genetic testing he had recently had revealed he was conceived via IVF and Yitzhak Yaniv is not his biological father.

- after Sara tells him she was conceived via IVF, he says he was, too, because his father had had a vasectomy after his first marriage; this, he said, was revealed in genetic testing he'd recently undergone and had been a big family secret (MM.org, [Chunk 5](#), 9/17/20)
- tells online doctor he will be getting genetic testing done at the complex chronic disease program and is being referred to the hereditary cancer program ([CoR](#), 9/23/19)
- misses a scheduled appointment with online doctor because Miriam's doctor worked him in at CCDP at a conflicting time ([CoR](#), 9/5/19); gets referral to the program from online doctor on 9/11/19 ([CoR](#), 9/11/19)
- warned by online doctor that he still needs a physical to be assessed for the Complex Chronic Disease Program at BC Women's Hospital he wants to enter (Miriam and her sister are in it) ([CoR](#), 9/4/19)
- will be screened by his mother's doctor of mitochondrial disease in January, has eye exam later this week ([CoR](#), 9/2/19)
- with Miriam present, he asks online doctor about mitochondrial disease, has appointment at clinic she uses in January 2020 ([CoR](#), 7/22/19)
- tells online doctor that mother and aunt have mitochondrial disease, profound fatigue, deafness, muscle weakness, Complex 4 deficiency, he has the same symptoms; wants Miriam's doctor to evaluate him ([CoR](#), 7/12/19); hearing test 2 weeks ago found he had 50% hearing loss in both ears, Yaniv tells online doctor ([CoR](#), 7/12/19)
- tells online doctor he wants referral to a complex disease program, worried about central sensitivity syndrome; told to get exam by GP first ([CoR](#), 7/8/19)

Mental Instability, Behavioral Problems

Yaniv suicide baits quite frequently to manipulate people and get attention, but he has in fact been treated for anxiety and depression. He exhibits little empathy and expresses rage and frustration in immature ways.

- Court released him from required weekly report-ins to a PO and getting psychological treatment under the PO's direction; continues to ban him from owning weapons; says he's applied for a permit to wear body armor; these were two of the conditions of his sentencing on the stun gun charge; also says he's getting "lots" of money from the government via ICBC, WCB, and the Ministry of Justice (MM [article](#), 12/14/20)

- “My depression is killing me tonight. The worst I’ve ever been in a long time, perhaps ever. The bullying this group does to me daily will one day soon make me take my life,” to a girl on Snapchat (Twitter [archive](#), 11/19/20)
- threatens suicide when the RCMP won’t do his bidding re: notices being posted around the community about his conduct; says on Live.Me, “I phone 911. I told them I’m going to kill myself. They ended up hanging up on me. I can’t take any of this anymore”; RCMP arrives with EMTs; they leave without Yaniv; Yaniv brags about it on Snapchat (WGKitty tweets, [archive 1](#), [archive 2](#); MM.org [article](#), 11/8/20; Live.Me summary, MM.org [article](#), 11/9/20)
- Yaniv has developmental issues and a neurological condition; was diagnosed with some behavioral and neuropsychological issues at the BC Children’s Hospital; has a learning disability, but was able to graduate from school and get a diploma; claims to have engaged in self-harm and has physical ailments. Yaniv often attends the hospital; meets the criteria for Borderline Personality Disorder – but has not been diagnosed. Likewise for gender dysphoria and “post-transition” (9/21/20 taser sentencing, transcript, MM.org [article](#), 11/2/20)
- Rebel Media reported that, at the stun gun sentencing, the judge said the court-ordered psych eval determined Yaniv has [borderline personality disorder](#), [gender dysphoria](#), and “post transition”) (KF post [18,503](#), 9/22/20)
- tells Sara on 9/8/20 that if she contacts MeowMix “I will do something to myself. That’s not a threat, that’s a fact”; she contacted MeowMix and the only thing he did was slap a kiddie filter on his face and go back to trolling teens on Snapchat (MM.org, [Chunk 11](#), 9/20/20; MM.org [article](#), 9/12/20)
- claims on 9/8/20 that he’s just spent long hours saving a Snapchat friend on the east coast from committing suicide (MM.org, [Chunk 11](#), 9/20/20; he’s previously claimed to have saved a number of young girls from killing themselves)
- tells Sara on 9/8/20 that his therapist says he has PTSD, severe PTSD (MM.org, [Chunk 11](#), 9/20/20)
- texts Sara on 9/7/20 that his anxiety is killing him and he needs help; there’s a bag on a bench under his window that contains metal and he believes it could be a bomb (MM.org, [Chunk 11](#), 9/20/20)
- texts Sara on 9/4/20, “I get nervous driving alone. Ugh. Fuck my anxiety.” (MM.org, [Chunk 11](#), 9/20/20)
- texts Sara on 9/3/20, “I’m not a MAP. But I do need therapy.” Asked what problems the therapy would address, he replied “I have encountered so much trauma. I need anxiety, PTSD and depression counseling. I can’t even concentrate anymore” (MM.org, [Chunk 10](#), 9/20/20)
- texts Sara on 9/3/20 after admitting he trolled a Snapchat group called “Quarantine queers,” “I trolled them, and yes, my trolling is stupid. It’s not fake though. I need medication, I need help. I just cried to crime assistance just now saying I am suicidal, now I will have a rove of cops come over to me. Great.”; a little while later: “Donald’s charges were dropped and it’s hard to stop myself from hurting myself” (MM.org, [Chunk 10](#), 9/20/20)
- texts Sara on 9/2/20 the speech he wrote for when he would propose to her; in it he says, “I love being ill if I know that you will be near and take care of me.” (MM.org, [Chunk 10](#), 9/20/20)
- tells Sara on 8/30/20 as she confronts him with his past sexualization of young girls, “I’ve been suicidal for days and you’re not helping ... I am suicidal if you don’t believe me ask my mom”; then he says, “My anxiety is through the roof” (MM.org, [Chunk 10](#), 9/20/20)
- tells Sara, “I have severe PTSD, severe anxiety, severe depression from all this [negative online and media information] and that’s what my doctor said” (MM.org, [Chunk 10](#), 9/20/20)

- tells Sara on 8/30/20 that he's having an extended anxiety attack and is crying, throwing up, after she confronts him about creeping on girls (MM.org, [Chunk 10](#), 9/20/20)
- tells Sara on 8/28/20 that he had his first session with his new therapist on 8/27 and it went well; it's a [CBT](#) therapist (MM.org, [Chunk 10](#), 9/20/20)
- texts Sara on 8/28/20, "I'm upset and extremely suicidal today"; he's expecting a video hearing on the civil defamation case with Amy Hamm; moments later he's making jokes about the name of someone else on the docket; hearing gets postponed (MM.org, [Chunk 10](#), 9/20/20)
- texts Sara on 8/24/20 that he deliberately takes more or less medication than he's prescribed or doesn't take it at all to hurt himself and has not told his mother that he does this (MM.org, [Chunk 9](#), 9/20/20)
- texts Sara that he's seen the psych reports (plural) the court ordered in the stun gun case and has no worries because he'll just be sentenced to counseling (MM.org, [Chunk 9](#), 9/20/20)
- texts Sara on 8/23/20 that he's gotten a new counselor; says the counselor is an amazing fit (MM.org, [Chunk 9](#), 9/20/20)
- on 8/23/20, Miriam texts Sara:

"Jessica locked herself in the bathroom not coming out as I will not leave her alone now!" Having learned that Sara is pressing Jonathan to reciprocate with nudes, Miriam is also highly suspicious of Sara. "The reason I am angry with you is because there is absolutely NO reason for you to ask for this private picture beside the desire to Pidt yhis in ... Post this on the internet in order to help others to implicate Jess legally! To cause her more problems!" (MeowMix [Document Library](#) > Chat Logs > Miriam and Sara Chats)
- on 8/19 Miriam texts Sara, "J has a lot of anxiety was screaming in the middle of the night cause of nigmars I don't know what to do about her she's so scared" (MeowMix [Document Library](#) > Chat Logs > Miriam and Sara Chats)
- on 8/7/20, Miriam asks Sara to try to calm Jonathan down:

"Please send this to Jess she is gettin* herself into, trouble again not thinking right! making treating remark about police not good please calm her down now! before she get arrested again! she is fuming! ... Not now! polic3 ar3 at j building i am goi g over bye! ... We going to deal with this at the detachment face to face by the advise of another rcmp9ofgicer from Surrey detachment that lives at J p,ace and his unit got flooded yesterday so he is angry and will help Jess. we will talk later. take care live you both. kiss to, Emily. ... She was miss treated by police palling for public pressure everything is ok niw! ... We are on the way home have advise from police what to do next! (MeowMix [Document Library](#) > Chat Logs > Miriam and Sara Chats)
- on 8/2/20. after "everyone is saying" Sara and Emily aren't where Sara says they are in the Toronto hospital, Miriam calls out Sara as a liar and a fake; Jonathan continues to believe Sara is what she says she is and convinces Miriam that is true (MeowMix [Document Library](#) > Chat Logs > Miriam and Sara Chats)
- says on SnapChat that he wants someone to kill him because he no longer wants to live (KF post [17,709](#), 8/2/20)
- Miriam warns Sara on 7/30/20 that JY will be suicidal if their "LOVE story" is just a Rebel News ploy (MM.org, [Miriam/Sara transcript](#), 9/17/20)
- Miriam messages concerns to the catfish Sara indicating Yaniv is suicidal; he and his mom are in Victoria because he wanted to ride the evening ferry and escape the stress he feels in Langley; Sara urges him to find a new psychologist and consider facilities (MM.org, [Chunk 5](#), 9/17/20)

- belatedly arrested for attacking Bexte on 1/13/20 at the Surrey Courthouse (7/9/20)
- tells Sara on 7/24/20 that he wants to find a new psychologist, “The one I had wasn’t working for me” (MM.org, [Chunk 4](#), 9/11/20); says on 7/30/20 that he had virtual sessions with the psychologist, that she wouldn’t let him talk about what he wanted to talk about, did all the talking herself, and was verbally abusive; victim assistance will pay for a psychologist but not a psychiatrist, psychologist helped with JYS’s second surgical assessment; previously saw a counselor but he says she laughed at his struggles and he never went back (MM.org, [Chunk 5](#), 9/17/20)
- tells Nicole he had to call the police on Miriam because his mother is so distraught over her assumption that he got COVID-19 by stepping into a hospital; “I don’t know what’s wrong with her. She’s never like this.”; seems to be visiting Nicole in Vernon at the time for Nicole’s birthday party (MM.org, [Nicole105](#), 6/19/20)
- on 6/11/20, the eve of his 33rd birthday, he tells Sara the past year has been the worst of his life and says it was filled with multiple suicide attempts (MM.org, [Chunk 2](#), 9/11/20)
- tells Sara on 6/8/20 that he’s seeing a therapist and he’s upset that “the girl that sexually assaulted me isn’t going to get charged”; “so I’m going to charge her privately via criminal prosecutions. Fuck her. I’ll do it my way. I’ll cause a shit storm!” “I can bypass the cops” (MM.org, [Chunk 2](#), 9/11/20)
- tells Sara on 6/4/20 that he’s been waking up at 2:45 a.m. with panic attacks (MM.org, [Chunk 1](#), 9/11/20)
- tells Sara on 5/31/20 that he has been sexually assaulted “a few times and it gets harder each and every time”; the last person to assault him was “a GIRL!”; “Yep. Bathroom inside of a court house, came in, took pics of me as I was - yeah”; “I get targeted by these anti-lgbtq activists that want pics of my ...” because they want attention; “It gives me nightmares still” (MM.org, [Chunk 1](#), 9/11/20)
- tells Nicole he had a panic attack after telling WorkSafe about the threats he receives in an effort to justify getting worker’s comp (MM.org, [Nicole123](#), 5/7/20)
- pleads guilty to one count of possessing an illegal stun gun, judge directs that the pre-sentencing report include a psych evaluation (3/16/20, [archive](#))
- tweets that someone should stop calling RCMP Langley to say he’s suicidal; someone with the handle OverItQQ tweets that Yaniv said he was suicidal and overdosing on meds so she reported it (KF posts [3,179](#), [61](#), 12/25/19; MeowMix [archive](#))
- tweets “I’ve been struggling deeply with my own Mental Health lately and I can’t hide from it anymore. I will not be social for the next little bit and I am sorry for that. I’m sorry for letting you all down” (KF post [15107](#), 12/15/19; MeowMix [archive](#)); it is soon revealed he used someone else’s Twitter message as his own
- “I am scared of a lot of things. A lot. I live in constant fear”; has a security panic button (p. 72, [MM transcript](#); KF [thread](#), 11/26/19)
- tells Katie on 10/30/19, “I need counselling. I’ve needed it for years, but instead I’ve used people way back as a method of coping, in totally wrong ways. I just cannot afford it and when I want to talk to my doctor about issues, I just tense up and never go forward with it” (KF [thread](#), 11/17/19)
- tells MandaPanda repeatedly that he has depression: 10/23 - “I’m not well my depression is killing me” (p. 115, [MM transcript](#), KF [thread](#), 11/26/19); 10/24 - depressed, not eating except for a Kit Kat bar (p. 117)
- tweets that Morgan Oger wants him to be the next Amanda Todd, a girl who lived within 20 minutes of his strata and who hung herself after being threatened and extorted online (MeowMix [archive](#), 5/28/19)
- tells online doctor that his GP has started him on Ativan, 0.5mg daily, helps him sleep well, seeing psychologist in two days’ time ([CoR](#), 5/28/19)

- says repeatedly that he's taking hormones that make him volatile ([KF post](#), 5/28/19; [KF post](#), 4/29/19; [KF post](#), 5/27/19); tells Sara repeatedly that the hormone shots make him horny and displays raunchy, very male behavior after he injects himself with female hormones (MM.org, [Chunks 5 & 6](#), 9/17/20)
- tweets "Ya suicide attempts. Every morning.... Think it's not real? It is." (MeowMix [archive](#), 5/26/19)
- has a "GPS" on at all times to summon help from 911 ([KF post](#), 5/26/19); the "GPS" has been a Living Well Companion GO ([KF post](#) re: his lawsuit against mom's building, 12/24/18)
- "I've been suicidal all day. I can't do this," 11/13/19 ([MM transcript](#), [KF thread](#), 11/26/19)
- tweets that he made suicide threats to two people at BCHRT "multiple times" while they were considering his complaints re: getting his male genitals waxed; identifies those officials as Daniel Varnals and Devyn Cousineau ([KF post](#), see the spoiler in it, 5/26/19)
- tweets that the RCMP came each time he attempted suicide - at least 10-14 times since March - according to a tweet on ([KF post](#), 5/26/19)
- tweeted "Yeah.. twice in the ER dept of the hospital in 4 days, one OD and failed suicide... another suicide attempt." ([KF post](#), 5/25/19; MeowMix [archive](#))
- has a personality disorder, according to one of his tweets, but hasn't specified which one ([KF post](#), 5/25/19) - possibly anxiety disorder see next point below
- states repeatedly that he has gender dysphoria (which DSM-5 does not categorize as a personality disorder, but IDC does) and anxiety (example, [archived tweet](#), 5/25/19)
- [5/22 and 5/23/19](#), ambulance trips to the ER, suicidal emoting on 5/21 and 5/23 - released only a few hours later and posted happily about counseling a girl in a public restroom on 5/22 and posted pic of himself in his tiara eating at Tim Horton's; ambulance trip, posts "these meds have done so much damage" ([KF post](#), 5/23/19)
- overdosed on Saxenda on 5/20/19
 - [he messages on FB](#) that he's injecting [Saxenda](#) to lose weight; in ambulance video, says he was [using too much](#)
 - posts two FB videos about having accidentally taken 5xs the Saxenda he should take; in both he says he's fine, asks people to text him, giggles; in one he's making the video from inside an ambulance (MeowTube [Medical 03](#), [Medical 04](#))
 - tells online doctor on 5/21/19 that he started Saxenda 6 days before, 0.6mg dose, but injected 3.0mg by mistake on 5/20/19 at 4 p.m.; taken to ER by ambulance, blood sugar readings were never in true hypoglycemic range, but 24 hours later he's still having nausea and acid reflux; told it may be 1-3 days before effects wear off. Told to stop loading up on sugar. ([CoR](#), 5/21/19)
 - later tweeted that the Saxenda OD was deliberate and intended to be fatal ([KF post](#)); repeats that assertion ([KF post](#), 5/28/19)
- tells online doctor he's stopped taking antidepressant and is feeling good, no insomnia or acute anxiety ([CoR](#), 5/20/19)
- posts video on being suicidal, says he's tried to commit suicide many times in the last few months (KF post [4,735](#), text summary post [4,736](#), 5/18/19)
- tells online doctor that he's started taking citalopram (Celexa) and is waking at 3 and 4 a.m. with bad anxiety and depression, thoughts of self-harm; wants to switch meds; has an appointment with a psychologist on 6/5 ([CoR](#), 5/18/19)

- tweets on 4/21/19 that he's prevented suicides by being a leader for young girls "and yes, I've prevented several" (MeowMix [archive](#))
- [involuntary trip to hospital](#) but says he never threatened to jump off that bridge - no info on what brought the authorities into the picture, 4/21/19; no info on what brought the authorities into the picture; home in a few hours (may be of note that Morgane Oger published his exposé of Yaniv's perving on 4/20 and Yaniv was being accused on Twitter of stealing charitable contributions then, too)
- tweets that he asked questions on Facebook about teaching young girls to use tampons in a ferry washroom because he was plagued by anxiety and suicidal urges; tried "many times" to kill himself at that point - 2018? (MeowMix [archive](#))
- in 2013, Louise Nussac calls him out for suicide baiting Cimorelli's young fans, which he appears to have done for more than a year (MeowMix [archive](#))

Conduct in Medical Settings

- tells Sara on 6/3/20 that his blood doesn't clot well ("I can't stop bleeding") and he'd told nurses "to screw off" when they once tried to give him a blood thinner (MM.org [Chunk 1](#), 9/11/20)
- sends Raygen a Snapchat video of him ranting about a woman at RCMP Langley telling him not to use the ambulance-call button he wears around his neck, that it's meant for "really, really very sick people" and he's using "too much resources"; he indignantly says he's a taxpayer and pays for the button so he will use it (MM.org, video gallery, [raygun03](#), undated but probably around April 2020)
- posts "Fuck you FHA!!" after someone at Fraser Health Authority said, "You're not Jessica. You're a family member," when he was trying to set appointments for tests ([KF post](#), 7/19/19)
- has called 911 for help while already in a hospital "multiple times" ([KF post](#), 7/7/19)
- says he was "removed from hospital by a transphobic nurse," Fraser Health's Peace Arch Hospital ([KF post](#), 7/1/19)
- mocked "old woman" who turned out to be a man for stinking the ER up with "old fart perfume" while saying he himself had collapsed in a hospital bathroom ([KF post](#), 6/23/19)
- mocked psych patients he observed in the ER while saying he was there because without brain surgery he will keep "collapsing," Surrey Memorial Hospital ([KF post](#), 6/19/19)
- tells Nicole his doctor wanted him to go to the ER for pain but he doesn't want to; does go but "I walked out. There not putting a fucking tube down my throat" (MM.org, [Nicole40-42](#), 4/19/20); was this a respiratory? or was he in for a GI because of stomach pain complaints?

Neurology

Yaniv has been diagnosed with a type of arachnoid cyst on the cerebellum known as a Blake's cyst that Yaniv has sometimes called a brain tumor or brain cancer, which it is not. He says he's been told it's causing him motor and cognitive problems and may be life threatening. However, he's also acknowledged, in a consultation with an online doctor, that he's been told the cyst does not need to be removed. A new round of MRIs in summer 2020 showed the cyst was not growing and a neurosurgeon told him there were no issues that needed to be addressed.

He's reported many neurological symptoms for which doctors found no basis, including intermittent paralysis. He's no longer given handicap parking permits and has been denied disability benefits. In September 2020, he began complaining of whiplash, which is covered in this section. Spinal problems, which are sometimes treated by neurologists, are covered in the Orthopedic section farther down.

Whiplash

- at sentencing for the illegal weapon charge, he's seen pacing and walking quickly around the courthouse, climbing 22 stairs twice after declining to use the elevator, wearing a heavy backpack, turning his head with ease repeatedly, and getting into his car without difficulty (MM.org [article](#), 9/21/20; [YouTube](#) of him leaving courthouse, 9/21/20; [additional videos](#), 9/21/20)
- complains on Snapchat that he's in terrible pain because of the car accident and has to inject a painkiller into his muscles; his claim is critiqued as unlikely (KF post [5,991](#), 9/21/20; [archived tweet](#))
- neighbor sees Yaniv running across the highway where he often jaywalks to reach his mother's strata ([archived tweet](#), 9/21/20)
- claims it was a high-speed crash and he's in terrible pain ([archived tweet](#), 9/20/20), must inject a pain killer into his muscles (KF [Snapchat image](#), 9/20/20); photos of the minimal car damage ([archived tweet](#), 9/20/20; KF post [5,584](#) with pix, 9/20/20)
- posts on SnapChat that "I'm in so much pain it's unreal" (KF post [5,576](#), 9/18/20) - may be part of his whiplash claim or from the L5/S1 injury
- Yaniv's car seen on 9/14/20 to have minor rear-end damage; a few hours later Yaniv is seen carried out of his strata on a stretcher, conscious, receiving oxygen; overhead at the hospital talking about severe whiplash; brought home by Miriam, 2 hours elapsed; he walked around like nothing was wrong with him, no neck brace (MM.org [article](#), 9/15/20; [archived tweets](#) of witness; [later tweet](#))

Blake's Pouch Cyst

- Yaniv has developmental issues and a neurological condition; was diagnosed with some behavioral and neuropsychological issues at the BC Children's Hospital; has a learning disability, but was able to graduate from school and get a diploma; claims to have engaged in self-harm and has physical ailments. Yaniv often attends the hospital; meets the criteria for Borderline Personality Disorder – but has not been diagnosed. Likewise for gender dysphoria and "post-transition" (9/21/20 taser sentencing, transcript, MM.org [article](#), 11/2/20)
- on 8/7/20, tweets Sara that his surgeon had just called "from neuro" to say there were "**no issues**" (MM.org, [Chunk 6](#), 9/17/20)
- on 7/30/20, complains to Sara that his neurosurgeon keeps rescheduling and he doesn't know if surgery is necessary on his "tumor" although he had a MRI and consult only 6 weeks before; then calls it a tumor / cyst, says it's not life threatening unless it's growing, surgery would entail installing a shunt, further surgery would be needed if the shunt gets clogged (MM.org, [Chunk 5](#), 9/17/20)
- tells Sara on 6/18/20 that he just had an early MRI and met his neurosurgeon - no cancer, no plans for surgery, "It's not a big issue I don't think" (MM.org, [Chunk 5](#), 9/17/20)
- tells Sara on 6/9/20 that he's gotten the surgery consult "happening" but may be referring to GRS, subsequent meet with a neurosurgeon though makes it likely that he was referring to that 6/18 appointment (MM.org, [Chunk 2](#), 9/11/20)

- tweets that he's had a neurological problem since birth that prevents him from holding a pen properly, thus giving him poor penmanship (KF post [2,900](#), 12/12/19); his lack of dexterity is apparent in his makeup videos (e.g., [MeowTube](#)); tells Sara on 7/30/20 that the Blake's cyst is what prevents him from holding a pen or makeup brush properly (MM.org, [Chunk 5](#), 9/17/20)
- tells MandaPanda on 11/9/19 that he does have a brain tumor and sends her an MRI image as proof (see discussion of the image below) (p. 176-178, [transcript](#), KF thread, 11/26/19)
- asks online doctor for a referral to a fifth neurologist, four have declined his referrals; **CT shows arachnoid cyst, specialist at the time said this was not likely of clinical significance**, seeing neurosurgeon in about a year, MRI booked for November; concerned cyst is causing stabbing and pins and needles pain in back and leg, difficulties with walking; walk-in clinic gave him Gabapentin, but it's not helping (see Orthopedic category for more about that), dizzy spells since June, spaces out, passed out three times, most recently on 8/1, has been to the ER each time, admitted back in June ([CoR](#), 9/2/19)
- says 4-5 neurology referrals have been rejected; has headaches, dizziness, syncope; had EEG that showed no seizure activity; CT/head was normal ([CoR](#), 8/28/19)
- tells online doctor that **neurosurgeon does not believe surgery is necessary** but will see Yaniv in a year to reassure him; legs numb, falls frequently, pain in left posterior area of head; waking every 2 hours, has not followed up on CPAP recommendation for apnea; wants referral to a complex chronic disease program, worried about central sensitivity syndrome; told to get exam by GP first ([CoR](#), 7/8/19)
- says in FB video that he has "very large tumor on the back of my brain" and has been given a June 2020 consultation with a neurosurgeon ([KF post](#), MeowTube [Whining 03](#), 7/8/19)
- says his brain tumor is expanding and he will have surgery late in 2019 or 2020 ([KF post](#), 6/30/19)
- tells online doctor he's using a scooter to get around because **Blake's cyst** is causing dizzy spells ([CoR](#), 6/27/19)
- tells the Langley town council he has a brain tumor ([KF post](#), 6/24/19)
- tweets "I have a brain tumor," says he's going to the hospital daily ([Twitter archive](#), 6/23/19)
- at the ER because without surgery he will keep "collapsing" ([KF post](#), 6/19/19)
- "I need to have brain surgery," not doing well, back at the hospital today ([KF post](#), 6/18/19)
- hospital report says he has a [Blake's cyst](#) in his brain, growing and pushing on the 3rd and 4th ventricles, referred for surgery; cyst is impairing cognitive and motor abilities, eye's twitching, can't walk straight ([CoR](#), 6/17/19)
- passed out at home, taken by ambulance to hospital, doesn't say why ([KF post](#), 6/11/19); 5 hours in the ER but no Dx ([KF post](#), 6/12/19); tells online doctor that he's had a "break down" in his relationship with his GP; last night around 9 p.m., he passed out in his living room and his medic alert device summoned EMTs and firefighters; he was taken to the ER, had a CT brain scan, ECG, CXR, blood work, arachnoid cyst noted in the cerebellum, referred to neurologist who takes care of Miriam, released at 2 a.m. ([CoR](#), 6/11/19)

MRI Image

- Yaniv sent an MRI image from a study done on 6/20/19 to MandaPanda on 11/9/19 (MM.org article; KF post [14,724](#)) to show that he had a brain tumor (Blake's cyst) (p. 176-178, [transcript](#), KF thread, 11/26/19). Kiwi Farms commenters with medical backgrounds shared the following observations condensed here before the [CoR](#) PDF provided confirmation of the arachnoid cyst:

- a Sagittal T1 MRI of the brain under low resolution with a measurement where the cerebellum should be, no indication of abnormality, though **an arachnoid cyst in the posterior fossa is a possibility** (whether such a cyst is harmless or not requires neurology consult); definitely not hemorrhage (Positron, KF post [175](#), 11/22/19); "report" button on the interface suggests it is a software doctors use; this section is near the midline as you can see many midline structures, such as the frontal sinus (Positron, KF post [7,197](#), 11/22/19)
- ventricles are too big which is associated with ASD, Alzheimer's, and schizophrenia; cerebellum's too small and shaped strangely, looks like he shouldn't be able to walk, probably a congenital problem rather than brain tumor (Mariposa Electricque, KF posts [14,795](#), and [14,800](#), 11/22/19)
- part of the cerebellum ("the walnut wrinkly bit in that black blob") seems to be missing; the green line shows they're measuring the fluid; ventricles look big; arachnoid cyst in the posterior fossa is possible, could be compressing the cerebellum, but it may just be an odd scan slice (Otterly, KF post [14,801](#), 11/22/19); possibly **Dandy Walker malformation?** symptoms fit (Otterly, KF post [178](#), 11/22/19). Dandy Walker info: [comparison image](#), [NIH](#), [DW Alliance](#), [NORD](#), [UCLA](#)
- could that white spot be a calcified tumour (pineal, but looks too far away or on the thalamus?); his previous talk about "brain tumour" instantly made me think "incidentaloma"; all the commentary on the cerebellum is interesting, I thought it was just the slice angle...but it was very hard to compare this scan on Dr. Google (Sevenatenine, KF post [177](#), 11/22/19); reply to that: Good catch! That bit looks too well-defined to be a tumor. Possibly just a normal pineal gland. (Positron, KF post [182](#), 11/22/19)
- when the MRI administered on 6/20/19; Yaniv complained of feeling "rushed," of not doing well, and of being served food he did not find appealing ([KF post](#), 6/21/19)

Hydrocephalus

- One of Null's Canadian sources says Yaniv has an issue with his filtering organs allowing excess fluid to collect in his skull ([hydrocephalus](#)), requiring a way to drain it ([7/3/19 stream](#) around the 55-min. mark; [KF post](#), 7/2/19 refers to it but contains slight wording error); hydrocephalus is a common effect of a Blake's pouch cyst, which blocks the circulation of the fluid that cushions the brain inside the skull
 - Yaniv went to the ER but walked out without learning anything because he saw the words "brain," "leaking," and "stint" ([stent](#) or [shunt](#)) somewhere and got scared ([KF post](#), 6/16/19) - this was in the same week he hinted he had a brain tumor, then said he didn't
 - One cause of hydrocephalus is the presence of a tumor or cyst
 - Dx questioned by medical historian (KF post [8](#), 7/24/19)

Other Neurological Symptoms

- Ataxia
 - says he has [ataxia](#), a degenerative disease of the nervous system that can cause lack of coordination and difficulty walking among other symptoms (KF post [333](#), 8/8/19); no confirmation, does not seem to have continued after his disability benefits claim was denied
 - seen at Miss BC pageant breakfast "flitting from one table of pageant girls to the next with full pep and vigour," no walker, no scooter, "no mobility restrictions whatsoever" ([KF post](#), 6/30/19); told it was inappropriate for him to be at the pageant breakfast ([KF post](#), 6/30/19)

- Unnamed "Chronic Condition"
 - messages Katie on 11/4/19 that his neurologist's office called to say his Dx wasn't correct, his condition may be worse; they attributed his loss of hearing to that wrong Dx ([slide](#), [KF thread](#)); also says to MandaPanda, "Please talk to me I just got the worst news ever about my health" (p. 153, [MM chat log](#), [KF thread](#), 11/26/19)
 - tells MandaPanda on 10/11/19, "My mom slept next to me when I was sick and had neurological issues as I kept fainting; to ensure I keep breathing" (p. 66, [MM chat log](#), [KF thread](#), 11/26/19); the breathing problem may actually be sleep apnea - see the Respiratory section for more information
 - doctor's letter for handicapped parking permit says Yaniv has "a chronic condition" (unnamed) that causes sudden onset of neurological symptoms for which no solution has been found ([KF post](#), 7/6/19); handicap parking tag noted to be missing from Yaniv's car (KF post [15,187](#), 12/21/19); by the end of 2019, he no longer had a handicap parking permit (KF post [15,187](#), 12/21/19) and his strata had ceased letting him park in a handicap space

- Seizures, Epilepsy, Syncope, Weakness Causing Collapse, Strokes
 - on 8/30/20, he tells Sara when confronted with pervy behavior in 2019, "I was in such a bad neurological state I don't even remember anything with all the seizures I had" (MM.org, [Chunk 10](#), 9/20/20)
 - frequently says he faints at work or after work, including while fainting in bed, prompting MandaPanda to tell him that's called sleeping. The fainting spells may be the product of uncontrolled diabetes or combining Rx's and alcohol. Examples from [MM chat log](#), [KF thread](#), 11/26/19:
 - fainted after work on 10/19/19 (p. 96)
 - fainted while doing brand rep work at a liquor store on 10/25/19 (p. 121)
 - fainted and fell asleep, 11/9/19 (p. 176)
 - faints "like at 9 my time," 11/10/19
 - his driving privileges were withdrawn for awhile but eventually he's test-driving cars from dealerships to make videos for his business site (KF post [2,417](#), 11/17/19) and drove to a 9/18/19 bottom surgery meeting with Katie as his passenger (KF [thread](#), 11/17/19); driving himself once again but parking in handicap spaces ([KF post](#), 11/7/19)
 - had **EEG that showed no seizure activity; CT/head was normal**; tells online doctor he's not using alcohol, drugs, or caffeine but has an energy drink every 4 days; says 4-5 neurology referrals have been rejected; has headaches, dizziness, syncope ([CoR](#), 8/28/19)
 - video of Yaniv collapsing on the floor yet grabbing his phone (Louie25529938, [KF thread](#), 8/8/19)
 - first says he had two "mini strokes" one morning at tribunal hearing ([KF post](#), [FB claim](#), 7/4/19), then says they were "something else" ([KF post](#), 7/4/19), and later says they were seizures and he has epilepsy ([KF post](#), 7/9/19)

- texts Nicole, “I just had a stroke. Fell unconscious in my bed. Waiting for paramedics. Pray for me”; “Ambulance won’t take me, same issues for the last 15 days can literally write a story here still going to try”: “I had a seizure” (MM.org, [Nicole25](#)), 6/25/19)
 - says in FB video, "I just keep dropping and falling," but no Dx, could be seizures or [syncope](#) ([KF post](#), 7/8/19)
 - suit against physiotherapy company says he may have had a seizure as a massage table collapsed under him ([notice](#) dated 9/4/19 re incident on 6/26/19); case settled for \$2,500 on 8/28/20 (MM.org [article](#), 9/3/20)
 - says when admiring a Miss Canada winner speaking on epilepsy awareness that [he'd asked for MRIs](#) for years but was told there was no need; describes what he thinks are symptoms of epilepsy to an online doctor, referencing Miss Canada’s presentation the previous day ([CoR](#), 4/30/19); MRIs done in June 2019 ([KF post](#), 6/21/19)
 - while riding mobility scooter through McDonald's drive-through, he says on video that he might "collapse again or have another seizure" ([video](#) with his narration, also in MM.org [archive](#), 6/20/19)
- Memory Problems
 - says at BCHRT hearing that his memory "is shot due to concussions" ([notes](#), 7/17/19)

Orthopedic - Arm, Back, Hip, Leg Problems

Yaniv’s lower spine appears flattened, that is, it lacks the normal curve of the lumbar region, in x rays made in 2019. He says he’s often in pain from an injury to the L5/S1 lumbosacral joint that occurred when a massage table collapsed under his weight on 6/26/19 and was made worse when a reporter allegedly drove into him on 8/9/19. The various falls he’s had could have caused or contributed to the problem. Another contributing factor could be the [over-supination](#) of his feet, a congenital condition for which he wore orthotics until he was 12 and which is known to cause back and hip pain.

- displays a large wrist brace without comment during a stream (video, MM.org [article](#), 11/26/20)
- claims to the RCMP and EMTs that he has a fused hip, which he seems to think is a medical problem but is actually a surgical treatment known as arthrodesis, a procedure that is rarely performed now that better options are available; given his pigeon-toed gait and history of orthotics, his problem is likely to be congenital (MM.org [article](#), 11/8/20)
- in a Snapchat blast that surfaced in November 2020, he says it “feels like a bullet has gone through the fucking side of my hip,” is wearing a wrist brace (MM.org, [article](#), vid 3, ~11:40, 12:20, 11/3/20)
- posts on SnapChat that “I’m in so much pain it’s unreal” (KF post [5,576](#), 9/18/20) - may be part of his whiplash claim or from the L5/S1 injury that preceded the massage table incident
- tells Sara on 8/28/20 he’s happy with the settlement of the massage table case (MM.org, [Chunk 10](#), 9/20/20); tells Sara the amount is confidential, but it was \$2,500 (MM.org [article](#), 9/3/20)

- Miriam texts Sara that she has a lot of [JY's] mobility equipment in storage, including the motorized scooter and an adult walker that "Emily" might use (MM.org, [Miriam/Sara transcript](#), 9/17/20)
- tells Sara on 7/14/20 that he's at the doctor because "I just need my pain meds injection" [[trigger point injections](#)] since he says the injections go into muscle tissue? [Epidurals](#) into the spine?; "I've actually cut back on a ton of my pain meds. I have a disc that's herniated that presses against the central nerve root" (MM.org, [Chunk 3](#), 9/11/20)
- between 5/22/20 and 5/26/20 he was turned down for a PADS service dog despite claiming to need one for mobility issues (MM.org, [Nicole70](#))
- tells MandaPanda on 11/19/19, "I get mobility impaired at random. I fell really hard and it messed me up so badly. I can't walk for distances without being in extreme pain"; "I don't complain about the pain. I deal with that"; she asks how it happened and he says "no idea" (p. 218, [MM chat log](#), [KF thread](#), 11/26/19)
- says he's on "heavy" pain medication on 11/8/19 (p. 173) and 11/9/19 (p. 177) ([MM chat log](#), [KF thread](#), 11/26/19)
- claims on 10/19/19 that a disc is pressing against a nerve and "My whole body is fucked" (p. 96, [MM chat log](#), [KF thread](#), 11/26/19)
- doesn't need any mobility devices to get around, according to Katie ([KF thread](#), 11/17/19)
- says on 10/7/19 that "I'm in so much pain again" from an injury to his spine at the [L5/S1 lumbosacral joint](#) that occurred when a physiotherapist's massage table partially collapsed in June 2019 and that was made worse "when Rebel media hit me with their car" in August 2019 (pp. 47 and 48, [MM chat log](#), [KF thread](#), 11/26/19; massage table case settled for \$2,500 on 8/28/20 (MM.org [article](#), 9/3/20)
- on 10/2/19 he says that he has "a huge problem with my spine" and that the massage table mishap happened "literally where the damaged spine is," meaning a pre-existing condition for which he was seeking PT ([KF thread](#), 11/26/19)
- tells online doctor that both legs hurt with a tingling pain, has numbness, going on for the last 4 months; low-back MRI this Friday; got Flexeril Rx from walk-in clinic; wants referral to chronic pain clinic at RCH; electromyograph (EMG) scheduled for 10/23, seeking family doctor from Murrayville practice; warned that the chronic pain program cannot accept patients still undergoing investigations to find treatable causes of their pain ([Co_R](#), 9/23/19)
- tells online doctor he needs a referral to a neurologist who will take him on as a patient, wants an L-spine MRI to evaluate pain and tingling in his leg for the last 3 months, Miriam's doctor at the chronic disease program will give him a spinal MRI; online doctors says he doesn't need the MRI/head planned for November (his second head MRI); reviewed ongoing symptoms - long list; gets referrals for neurologist, x-rays of lower back and hand plus MRI L-spine, and the complex disease program. ([CoR](#), 9/11/19)
- wants referral to a different neurologist ([CoR](#), 9/4/19)
- photographed on the hoof at a Telus store, but the scooter may have been parked outside ([KF thread](#), 8/17/19)
- tells Babylon app doctor about it on 8/12 and 8/13, says hip was hurting before the incident but hurts more now, went to walk-in clinic after the incident ([CoR](#))
- discusses hip/femur x ray with online doctor, no fractures; was in the hospital the night of 8/12-13 after what he said was a seizure; he "spaced out" for 10-15 minutes while going for a walk at 10 p.m.; EEG tomorrow, CT/head this Friday ordered by walk-in clinic doctor after the 8/8 car incident; requests multiple referrals to specialists but is told no, needs in-person exam first; says he's located a family doctor through Trans-care BC but no appointment scheduled yet ([CoR](#), 8/13/19)

- tells online doctor that a reporter drove into him on 8/9 and police are involved; left hip was hurting before the incident but was hurting more afterward; doctor has him perform various movements in front of the video cam and notes problems in lifting the left knee and squatting fully, says Yaniv needs an in-person examination at a clinic ([CoR](#), 8/12/19)
- the walker-chasing encounter with Kean Bexte in front of his condo was on 8/9/19 (Bexte's video, KF post [1](#); Yaniv's hit-and-run accusation, KF post [7](#))
- says he fell hard in the shower 8/1/19 and split elbow open
 - observed being taken away by ambulance (KF posts [25](#), 8/2; [34](#), 8/5/19)
 - posts pic and vid on 8/3/19 in swimsuit at a pool, no sign of elbow gash or mobility problems (KF posts [183](#), [184](#), 8/5/19)
 - tells online doctor that he fell in the bathtub on 8/1 and went to the ER at Ridge Meadows but the CT wasn't working and they also didn't feel that x rays of his body were necessary; online doctor says Yaniv has to be examined in person before any referrals for those things are given ([CoR](#), 8/2/19)
 - tells an online doctor again about his fall in the tub, how his elbow bled, how he called 911 and was taken to Ridge Meadows where they were unable to do any imaging, how he's awaiting an EEG, has a scooter and walker for ataxia, can't walk long distances; he told again to find a GP ([CoR](#), 8/8/19)
- says he's disabled, not because he limps but because he collapses ([tweet](#), 7/19/19); in 2020 he will say he is disabled because of hearing loss, see the Audiology section for details
- was observed walking around BCHRT on breaks without difficulty ([tweet](#), 7/19/19)
- Null's been told Yaniv's depending on disability payments, hence the scooter, because his SEO business is essentially bankrupt ([KF post](#), 7/17/19); a few days later, Yaniv tweets, "No, I am not on disability" (MM.org, [DonaldSmith73](#), 11/24/19)
- tweets "I'm not on disability" (MM.org, [MedDis6](#), 8/7/19)
- posts video of himself walking easily along a road and saying he had been driving around checking the areas he committed to maintain - should not be driving because of his recent seizures, but perhaps Miriam was really at the wheel ([KF post](#), 7/14/19)
- tweets that recurring lower body paralysis "wears off" after a few minutes to hours; when asked what kind of condition does that, he replies, "I have no clue it's under investigation" ([Twitter archive](#), 7/12/19)
- says in FB video that he has scooter and walker and isn't supposed to walk ([KF post](#), MeowTube [Whining 03](#), 7/8/19)
- during Yaniv's scooter days, WGKitty saw him walk up a flight of stairs and also run around the strata building looking for a sticker WGKitty pretended on Twitter that they'd posted with information about Yaniv (WGKitty Q&A [archive](#), 12/20/19)
- tweets that he has been unable to rise from the toilet in hospital bathrooms multiple times "at random" and has then called 911 for help ([KF post](#), 7/7/19)
- tweets doctor's note for a handicapped parking permit because of "neurological symptoms" ([KF post](#), note showing "Sparc," the permit authority, 7/6/19; [KF post](#), note showing full reason, 7/6/19)
- photographed getting off and on scooter, standing and bending on a Skytrain without difficulty ([KF post](#), 7/5/19)
- says he can't feel his lower body ([KF post](#), 7/1/19)

- seen at Miss BC pageant breakfast on 6/30 "flitting from one table of pageant girls to the next with full pep and vigour," no walker, no scooter, "no mobility restrictions whatsoever" ([KF post](#), 7/9/19 referring to earlier incident); told it was inappropriate for him to be there ([KF post](#), 6/30/19) and returned 7/1 in a wheelchair to film contestants ([KF post](#), 7/1/19)
- on 6/27/19, the day after the massage table incident, Yaniv contacted a telemedicine doctor and asked about totally unrelated matters; no mention of the incident or of back pain ([CoR](#) for that date).
- reports shooting pain down his arm, cannot walk in the hours after a town council appearance made sitting in a wheelchair ([KF post](#), 6/26/19)
- goes to a physiotherapist for treatment of his balance problem on 6/26/19 and massage table partially collapses beneath his weight, causing him pain; may have had seizure after the table collapsed ([KF thread](#), 9/4/19; [notice](#) of claim; 10/11 certificate of readiness - medical information ([CoR](#)); case settled for \$2,500 on 8/28/20 ([MM.org article](#), 9/3/20)
- videos himself riding a mobility scooter in a McDonald's drive-through lane to get iced tea ([video](#) with his narration, also in [MM.org archive](#), 6/20/19)
- asked online doctor for referral to get orthotics, hasn't worn them since he was 12, showed how over-supinated his feet are ([CoR](#), 4/23/19)
- told Cimorelli fan Riley on 3/18/15, "I hurt my back really bad" ([MM.org](#), [Riley's gallery](#))

Respiratory

In some videos, Yaniv is panting even though he's standing or sitting still. He has oxygen at home and has made a video while wearing a cannula and a breathing monitor. He's also requested and been given a number of sleep apnea studies that have found him to have mild apnea. His mother and his aunt have apnea and his father had it as well. He has not wanted to sleep in a CPAP mask. His breathing is often labored even when he's not doing anything strenuous.

- tells Sara he had trouble breathing because of the "fire" on the night of August 9/10, shows video of bathroom ceiling and says he's going to the insurance company; says he has \$50k in his insurance claim payout for relocation; he first told her about the #401 mishap as it was happening on August 6 and said nothing more until August 10 ([MM.org](#), [Chunk 6](#), 9/17/20)
- the night after a fire sprinkler in an apartment two floors above his went off, Yaniv says his "airways closed for 12 minutes" as he slept because water from above had infiltrated his carpet; he sues the couple who own the apartment where the mishap occurred ([MM.org article](#), 9/2/20)
- in bantering on Twitter, Yaniv justifies having called an ambulance by saying he was told to do that by his doctor after he complained of breathing issues, no indication of when that ambulance run occurred ([KF post 4.551](#), 4/22/20); one was observed, though, on 4/9
- tells Nicole his doctor wanted him to go to the ER for pain but he doesn't want to; does go but "I walked out. There not putting a fucking tube down my throat" ([MM.org](#), [Nicole40-42](#), 4/19/20); was this a respiratory? or was he in for a GI because of stomach pain complaints?
- tells MandaPanda on 10/11/19, "My mom slept next to me when I was sick and had neurological issues as I kept fainting; to ensure I keep breathing" (p. 66, transcript, [KF thread](#), 11/26/19)
- panting while riding a mobility scooter ([video](#) with his narration, also in [MM.org archive](#), 6/20/19)

- wearing cannula and breathing monitor while sitting at home ([MeowTube video](#), 4/23/19; [KF post](#))
- several studies have detected mild sleep apnea:
 - complains to online doctor that he's tired even though he gets 8 hours of sleep; wants a sleep study at Snore MD in Langley because Yitzhak had sleep apnea ([CoR](#), 4/14/19)
 - nostril painful after wearing a sleep apnea monitor with nasal prongs; online doctor tells him to swab on some vaseline or antibiotic ointment with a Q-tip ([CoR](#), 4/19/19)
 - told he has mild apnea, doesn't want CPAP mask, told to lose weight instead ([CoR](#), 4/30/19)
 - tells online doctor clinic has told him to use a CPAP mask for mild apnea and he doesn't want to ([CoR](#), 5/16/19)
 - tells online doctor he's waking every 2 hours, has not followed up on CPAP recommendation for apnea ([CoR](#), 7/7/19)
 - gets a referral to another sleep clinic for another apnea test ([CoR](#), 8/2/19)
 - tells online doctor that he hasn't tried CPAP yet ([CoR](#), 8/13/19)
 - calls online doctor about sleep apnea again; doctor notes Yaniv has done the test five or six times ([CoR](#), 8/26/19):
 - Yaniv says the tests are inconclusive as he removes or dislodges the monitor while asleep
 - has been seen at Snore MD, RHS Canada, and Medpro
 - wants to do it again through Miriam's respirologist - she and her sister have sleep apnea, too (as did Yitzhak, Yaniv said in a previous consultation)
 - requests referral to Abbotsford sleep clinic ([CoR](#), 8/28/19)
- tells online doctor he has bronchitis, again gets antibiotics and doesn't mention it further ([CoR](#), 5/14/19)
- says he's nearly done with the antibiotics and got a flu shot two days ago, then developed mucus and vomiting, coughing, nasal congestion, post nasal drip, sore throat, bit of a headache, unsure if he has fever; Rx'd Avamys for the next 1-2 weeks to help with congestion ([CoR](#), 3/30/19)
- tells online doctor that he's been sick for 4 days with congestion, cough, sinus headache, had sinus surgery in 2006; asks about gender surgery; asks for an order for blood tests that his GP ordered, but Yaniv lost the paperwork; told to see his GP about it and is given an Rx for antibiotics ([CoR](#), 3/21/19)
- tells an online doctor that he thinks his GP is out of town and he needs to talk to someone because he has sinus congestion and is coughing up mucus, no high temperature; told symptoms sound like flu or allergies, use OTCs ([CoR](#), 3/20/19)
- says he had serious medical incident as a result of the smoke from burning herbs at a purification ceremony backstage at a theater on 5/22/16 where was preparing to give a tech talk, went home and did not request or receive medical care; sought \$25,000, eventually gets a \$500 settlement ([small claims court filing](#); MeowMix [archive](#); KF post [246](#), 11/23/18)
- triggered after smelling cleaning product in 2018 (KF post [1019](#), 12/24/18), \$35,000 sought, claim withdrawn on 2/14/19; Miriam's related \$35,000 claim, [MM.org documents](#), also withdrawn)
- had surgery on his sinuses in 2006 ([CoR](#), 3/20/19)

Sexuality

Yaniv was born male and has not had gender reassignment surgery. In a court filing, he stated that he legally transitioned in 2017. He has stated that he has been taking synthetic cross-sex hormones since 2018, changed his name to Jessica Yaniv in 2019, and changed his name again to Jessica Simpson in 2020.

For many years, Yaniv has sent dick pix and frankly described himself as having a penis, once saying it was a tiny penis and once saying he had deformed genitals. As he began holding himself out as a transgendered woman, he began claiming to have menstrual periods and female sex organs. When confronted about his conflicting claims about his birth sex and genitalia, he began trying to hedge his statements by claiming to be intersex, which he wrongly presumed to be the same as being a hermaphrodite. His mother gave both conflicting and false testimony before the BC Human Rights Tribunal to that effect.

In September 2019, he began undergoing assessment for gender reassignment surgery. Prior to that, he lied about already having had the surgery and was pressured before the tribunal to back off, first saying the surgery was scheduled; then admitting it had not been scheduled. In fact, he had not yet even been assessed for surgery. Though he has claimed to have gender dysphoria, he asked a woman to refer to his shrunken penis as his “cock,” told her he wanted to ejaculate in her vagina and on her body, and wanted her to ask him to “do me harder, Jessica” - all highly inconsistent with gender dysphoria.

He has florid menophilia and displays persistent pedophilic behavior toward pre-pubescent girls and young teen girls.

Genitalia and Reproductive Organs

Intersex

- asked on 9/7/20 whether he has both a penis and a vagina, he texts Sara “I can’t really explain things about that”; when asked again, he says “Maybe I am”; eventually says he has ovaries, and has cousins who are intersex, “It’s in my family”; he adds, “I’m going through genetic testing so I don’t know” (MM.org, [Chunk 11](#), 9/20/20)
- tells MandaPanda he has ovaries and “most likely an inactive uterus” and says he’s “trying to get that scanned” (p. 155); says “My aunt has it too” and quotes an oversimplified description of intersex conditions (p. 156, [MM chat log](#), [KF thread](#), 11/26/19)
- DMs surface in which Yaniv claims he has ovaries and possibly an inactive uterus, a condition his aunt has; also says he’s “super gender dysphoric” and can’t see himself with male parts (KF post [171](#), 11/21/19)
- during autumn 2019 meeting for GRS candidates, he asked questions only pertinent to male genitals; made no pretense of being intersex, according to Katie (KF [thread](#), 11/17/19)
- says during a stream that he’s “a biological male but intersex” and identifies as female; has penis and testicles, both his penis and his clit are circumcised (KF [archive](#), 8/1/19)
- says on Irish radio that he has testicles and a penis as well as intersex genitalia “which means I was born with both parts”; when the host, Niall Boylan, says, “Well, you don’t have a vagina,” Yaniv says, “It’s

complicated"; Yaniv doesn't object when the host says Yaniv has ovaries ([KF post 1](#), [KF post 2](#), [audio](#), 7/22/19)

- testifies that his genitals are deformed, but won't be specific ([notes](#), 7/17/19)
- testifies that he is intersex and says intersex means "being both male and female" and "one thing works and one thing doesn't" ([notes](#), 7/17/19)
- at hearing, asks his mother under oath if he was born a boy, girl or both, she says both; says he wanted to be a girl and came out in July (no year given); she repeatedly misgenders him ([KF post](#), 7/16/19); repeats testimony the following day, adds that she raised him as transgender then says she didn't know he was transgender until he came out to her ([notes](#), 7/17/19) (In 2020, Yaniv tells "Sara" that his mother always knew: "My mom knew for years I was gender fluid / trans from a young age, but we kind of kept it a secret from him," meaning his father (MM.org, [Chunk 3](#), 9/11/20)
- claims in 2018 sex toy reviews that he has a clitoris, a vagina, and a penis (KF post [381](#), 11/28/18)
- "I was born with both reproductive organs" ([KF post](#), 11/9/18)

Male

- tells Sara on 9/7/20 that he did not have his sperm tested for viability before it was frozen and banked; says on 9/8/20 he pays \$300 a year to keep it frozen, receipt from the Olive Fertility Centre (MM.org, [Chunk 11](#), 9/20/20; [archived tweet](#), 9/9/20)
- tells Sara on 7/20/20 that hormone treatments have left him unable to maintain an erection and "I took hormone blockers that stopped my Testosterone building up. So that means, I don't produce sperm, so I can't come. I used to be about 5.5 inches, but hormones do affect that so it's maybe 3 now, or 4." (MM.org, [Chunk 4](#), 9/11/20)
- tells Sara on 7/12/20 that he has his sperm frozen before he began hormone therapy (MM.org, [Chunk 3](#), 9/11/20)
- tells a group of teens on Snapchat on May 7-8, 2020, that his testosterone level was 12+ and is now 0.8 - see his claim of it having been 14 in the Alex Jones July 2019 item below (MM.org [article](#), 9/2/20)
- tells Sara on 6/3/20 that taking synthetic hormones has affected his penis, "I'm not huge" (MM.org, [Chunk 1](#), 9/11/20)
- sends a photograph of his penis to a woman on a lesbian dating app; picture ends up on KF; MM confirmed it was Yaniv after publishing it (MM [article](#), KF post [16.943](#), 5/20/20)
- tells a 16-year-old on Snapchat that he wants to "stick my meat in" after removing her tampon and that he dreamed the "pussy fairy" had given him the "coin slot pussy" he desires (MeowMix [archive](#), 4/19/20)
- describes his penis as tiny (KF post [2.552](#), 11/23/19)
- says on 11/11/19 "I have a dick" (p. 184) but doesn't get erections or come anymore because he's on hormones (pp. 189-90), but on 10/9/19 tells her that though his penis is tiny, it still gets hard (pp. 60) (MM [chat log](#), KF [thread](#), 11/26/19)
- BCHRT decision: 'I am satisfied, based on Ms. Yaniv's representations to the Respondents that she has "male parts", "used to be a boy", and has not "gone through surgery yet", as well as her evidence in these hearings that she has "male parts", that Ms. Yaniv was seeking to have hair removed from a scrotum. Whether or not she may also have a vulva is not ultimately determinative of any issue in this complaint

and so I do not need to engage further with that question.’ ([JCCE](#), p 10, para 22, 10/22/19); appears to again be seeking out aestheticians who will decline to perform Brazilians on him (MM.org [article](#), 9/18/20)

- tells Alex Jones that before hormone therapy his testosterone level was 14 and is now 1.2 ([AJ stream](#), ~16:34; KF posts [74](#), [76](#), [123](#), 7/23/19); later says on Snapchat that his pre-trans level was 12+, see 9/2/20 item above)
- says on Irish radio that he has testicles and a penis as well as intersex genitalia ([KF post 1](#), [KF post 2](#) [MM chat log](#), 7/22/19)
- tweets page of medical questionnaire asking gynecological questions and says, "Obviously, I can't answer that" ([archived tweet](#), 7/8/19)
- says at tribunal hearing that he has male genitals and lied to waxing service provider about having a period when requesting service ([Twitter archive 1](#), [Twitter archive 2](#), 7/7/19 report on 7/5 hearing)
- sends online doctor a picture of a skin tag on his scrotum; wants STI tests even though he hasn't been sexually active for the last 5 years ([CoR](#), 4/27/19)
- online doctor notes that Yaniv's testosterone dropped from 1.8 to 1.1 on an April test ([CoR](#), 4/16/19)
- online doctor notes, "You were born a male and you are on hormone replacement therapy" ([CoR](#), 4/14/19)
- "I still have my male genitals though is that ok? I haven't had surgery" - messaging a salon, 3/2018 (KF [OP](#), see the spoiler labeled "I have a dick and balls")
- "Ally was great doing my Brazillian" ([KF post](#), 2018)
- says he's M2F while also saying he's had a period since he was 13 ([KF post](#), see spoiler, 12/30/18)
- says "I still have 'that' down there unfortunately" in a tweet about all his BCHRT ball waxing complaints being against East Indian women ([KF post](#), 12/28/18, displaying screen shot from 4/14/18)
- says he has a dick when pestering women on Facebook about what he can get away with in a women's changing room at a gym he just joined ([KF post](#), 2018)
- said in April 2015 that Sears needed "to go back to the anatomy books so they can see that I am NOT a woman" ([KF post](#), 7/11/19)
- in 2014 Twitter DMs with a Texas woman, he says he wears pads because of "my problem," not because he menstruates, and declares "I'm not a girl"; refers to his penis and balls ([KF thread](#), 11/13/19)
- in 2014 or 2015 texts with Jessica Rumpel, Yaniv said he does not have a vagina but wanted one "so I can have fun" ([KF post](#), 8/23/19)
- in 2009, Yaniv sent pictures of his genitals to a 16-year-old girl showing he had a penis, but no vulva ([archived](#) Post-Millennial article, 8/19/19)
- in July 2008 chats when he was in college, he said he had a penis and wore menstrual pads because, since the age of 13, he had a constant clear discharge that was never bloody; a bloody discharge came from his rectum, however ([chat logs](#))

Female

- states during a live stream that he has "a fucking pussy" (MM [article](#), 12/11/20)
- tells "Sara" in 2020, "I used to be gender fluid, but I don't like that term. It's when sometimes you're male, sometimes you're female. Like having a fluid gender. Gender fluid is kind of like non-binary. But I've

always seen myself as female and always identified as such. Like even though I'm trans, I don't make it a focal point of myself, so I describe myself as female." (MM.org [Chunk 3](#), 9/11/20)

- seen at a women-only gym ([tweet](#), [archived tweet](#), 8/6/20 - same day as sprinkler incident)
- says on Irish radio that he has intersex genitalia "which means I was born with both parts"; when the host says, "Well, you don't have a vagina," Yaniv says, "It's complicated"; Yaniv doesn't object when the host says Yaniv has ovaries ([KF post 1](#), [KF post 2](#) [MM chat log](#), 7/22/19)
- testifies that when he was six, a specialist diagnosed him "as a girl" ([notes](#), 7/17/19) (another transcript says he was diagnosed with GID)
- refuses to answer when asked at hearing if he has a vulva, then says "I maintain I have a vulva. I will not go further" ([notes](#), 7/17/19)
- tweets that he has a uterus ([KF post](#), 7/16/19)
- tweets "At least my pussy is tight and not loose after pushing out a 10 pound baby" before hyping a brand of sex toys ([KF post](#), 7/14/19)
- "Is it ok for these shits to try and take pictures of my vagina?" ([KF post](#), 5/28/19)
- says on Facebook that he doesn't consider himself trans; he considers himself "full female" ([KF post](#), 4/29/19)
- **he menstruates - yes?**
 - tries to get a free Livia vibrator to "review" its effects on his menstrual cramps (KF post [1.905](#), 10/17/19); second attempt (KF post [3.086](#), 12/17/19); posts demo (KF [post](#) 16,535, 4/18/20)
 - tweets that he can't go into a public pool in Langley because "My period started so ya, couldn't go into the pool. But it was so much fun! Forgot my tampons in my other bag fml." (KF post [420](#), 8/11/19; [Sputnik News article](#))
 - says during a stream with Mark Hughes that he menstruates and has asked females in restrooms for tampons (KF [archive](#), 8/1/19, ~28:30 min. mark)
 - mother says under oath that he began having periods at 13 or 14 and has had abdominal cramping all his life ([KF post](#), 7/16/19); she repeats that testimony the following day ([notes](#), 7/17/19)
 - tweets about "my period" and then says no one can know whether he has a uterus or not ([KF post](#), 7/8/19)
 - says he has had a period since he was 13, but in same exchange says he's M2F ([KF post](#), see spoiler; some time bfr 12/30/18)
- **he menstruates - no?**
 - texts Sara on 9/3/20, "It was really hard through my pre teens not going through female puberty. So that's where really wanting to get my period and putting my mind into it really got to" (MM.org, [Chunk 10](#), 9/20/20)
 - offended when asked at a tribunal hearing whether he menstruates and will only say that he was not menstruating when he tried to book genital waxing ([KF post](#), 7/5/19)
 - told two teen girls in 2014 that he wears pads because he sweats so much (KF post [221](#), 8/23/19; KF post [196](#), 1/17/20)
 - during 2008 chats he had while in college, he said that at 13 he began having a clear discharge from his penis that was never bloody ([chatlogs](#))

- **he has PMS and menstrual cramps?**

- tweets that it's his time of the month ([archive](#), 1/5/20)
- complained to Katie of having cramps every other day (KF [thread](#), 11/17/19)
- "I get INSANE cramps" and is having them on 11/11, says they're caused by hormones and are "bladder and muscle cramps" (p. 186, [MM chat log](#), KF [thread](#), 11/26/19)
- tweets a pic of cake with, "It's that time. #girltime #pms #LGBTQ" (KF post [2259](#), 11/8/19)
- tweets about estrogen's effect on smooth muscle tissue giving trannies cramps, which he equates with having periods ([KF post](#), 10/13/19)
- tweets "It's that time of the month. Cravings are craaaaaazy omg" (KF post [1668](#), 10/3/19); referring to a teen victim who came forward, "I'm on my period and bitchy as hell so if you want me to tear her a new asshole I totally can with my hands" ([Archive](#), 10/3/19); still complaining period cravings three days later (KF post [1723](#), 10/6/19)
- tells MandaPanda on 10/1/19 that a hormone injection is giving him "serious PMS"; on 10/9/19 that he's on his period (p. 58, [MM chat log](#)); on 10/14, "I think I'm getting my period again; cramps suck (p. 78) yeah, getting my period; cramping, leg pain, bloating, woozy; going to the doctor tomorrow for hormone injections and he's not looking forward to them because they hurt; he gets two injected into his ass on 10/15 (pp. 79, 82); says he on his period on 11/18/19 (p. 210) ([MM chat log](#), KF [thread](#), 11/26/19)
- claims to have PMS ([KF post](#), 5/27/19)
- "Tell that to the cramps, pads... and the huge investment in Midol" when responding to an assertion that he does not menstruate ([KF post](#), [tweet](#), 5/26/19)
- says he has reported recurring cramps to his doctors and has a doctor's appointment "like every 2 days" ([KF post](#), 5/26/19); in the more than 30 consultations with online doctors that he'd had before 5/26, he mentioned cramping only once and he ascribed it to having eaten gluten ([CoR](#), 5/7/19)

- **his breasts function as female breasts do?**

- pulled out a moob on a live stream," (MM [article](#), 12/11/20)
- tells Sara on 7/20/20 that a doctor had advised him not to get breast implants because of his family's history of cancer; Sara raises doubts about that and later that day he said he would get a second opinion (MM.org, [Chunk 4](#), 9/11/20)
- exposes moobs online ([MM.org](#), 6/24/20)
- breast cancer scare beginning in June 2019, see separate category ([possible](#) in men but rare)
- surprised a mammogram hurt so much ([KF post](#), 6/14/19); goes for breast exams every other week, according to Katie (KF [thread](#), 11/17/19)
- shows himself wearing a bra during a stream with Mark Hughes, pulls cup down to show nip (KF [archive](#), 8/1/19, ~33:30 min. mark)
- tells online doctor he went to a walk-in clinic for pain in his right breast, doctor could feel lump, will have ultrasound later today ([CoR](#), 6/11/19)
- "You do realize my breasts produce colostrum, right??" ([KF post](#), 5/27/19)
- fake boobs revealed on camera during town council meeting ([KF post](#), 5/27/19)

- wants referral to gynecologist because of pain in right breast he says he's had since March 2019, feels no lumps, had ultrasound a month ago, online doctor sees no breast symptoms, says may be effect of estrogen, refers to gynecologist ([CoR](#), 7/22/19)
- started taking progesterone and asks online doctor how long it will take his breasts to develop ([CoR](#), 5/7/19)
- tells online doctor that since his estradiol dose was increased from 2mg to 4mg per day a couple of months ago, he's had pain in his right breast; aunt and grandmother had breast cancer; no redness, lump, or other symptoms; told breast pain is common with hormone treatment; will see endocrinologist again in July ([CoR](#), 3/22/19)
- **he sees a gynecologist?**
 - tells Sara on 6/4/20 that Langley Gynaecology has refused to see him before or after GRS (MM.org, [Chunk 1](#), 9/11/20)
 - tweets about a gynecologist refusing to see him because he's trans - not clear if he sought an appointment because the ER may have given him a referral the previous day (KF post [2,713](#), 12/3/19; MeowMix [archive](#))
 - has been unable to find a gynecologist who will treat him, according to Katie (KF [thread](#), 11/17/19)
 - says in FB video that gynecologist found no signs of cancer "in that area" ([KF post](#), MeowTube [Whining 03](#), 7/8/19); received referral to gynecologist for a pap smear ([KF post](#), 6/14/19); the pap smear technique is [used on men](#) to detect anal carcinoma
- **he's taking voice training?**
 - tells Sara on 6/4/20 he's taking voice training and "My pitch is supposed to be between 180 - 220 gz and it's at 200 - 240 hz (without it sounding super high.. yet)" (MM.org, [Chunk 1](#), 9/11/20)

Gender Reassignment Surgery

- WGKitty says a letter carrier left and envelope in WGKitty's mailbox from GrS Montréal meant for Yaniv saying he is scheduled for surgery in January; Yaniv complains to police, claiming WGKitty broke into his mailbox ([Twitter archive](#), 11/27/20)
- Snapchat surfaces of him saying that BC's health plan won't pay for GRS during the covid shutdown period; he wants to risk getting sick but can't pay for GRS on his own, date of vid uncertain (MM.org, [2nd vid](#), ~1:20, 11/3/20)
- texts Sara on 8/24/20 that when being evaluated for GRS in Montreal, he was frightened about having his genitals viewed via video and ended the session early, causing him to fear he might have been disqualified for surgery; he now presses them for a surgery date every couple of days and they are getting annoyed with him (MM.org, [Chunk 9](#), 9/20/20)
- texts Sara on 7/20/20 that "I haven't done any surgeries yet. It's just the hormone replacement that I've been on for almost 1.7 years" (MM.org, [Chunk 4](#), 9/11/20)
- Miriam texts Sara that she thinks bottom surgery carries too many risks, and that voice feminization surgery would be the best first step because having a male voice and female body "is what causing her the most problems!" (MeowMix [Document Library](#) > Chat Logs > Miriam and Sara Chats)
- tells Sara on 7/19/20 during his trip east because his "stepdaughter" underwent brain surgery (MM.org, [Chunk 4](#), 9/11/20):

- "I'm going to see my surgeon in Montréal. If I'm so close why not go and get that pre-op visit done"
- says it's for bottom surgery, specifically vaginoplasty; next day he says he'll also have an "oreectomy," meaning an orchiectomy
- says top surgery is too risky because of the history of cancer in his family (but says on 7/20/20 he wants a second opinion on getting breast implants though BC's health plan won't cover the surgery because he's more than an AA cup)
- says he's completed the pre-op hormone and psychological assessments
- he fears surgery will be delayed because of his "excess weight" but no one's mentioned that possibility
- streams outside Montreal GRS clinic, where he has no appointment; gets to ask admin staff a few questions and then has to leave ([MM.org article](#), 7/19/20; [tweet](#), [archived tweet](#); MM.org, [Chunk 4](#), 9/11/20)
- texts Sara on 7/18/20, "I know you would have done the same for me and flown to be with me in Montréal while I undergo surgery," indicating that he's mentally replaced Katie with Sara as his support person for his GRS surgery and recovery; also, on 7/20/20: "I'll be in Montréal for 10 day's. So of course I'll want you here. I'm so excited" (MM.org, [Chunk 4](#), 9/11/20)
- tells Sara on 6/9/20 that he's gotten the surgery consult "happening" but may be referring to the neurosurgery consultation he'd been waiting a year for re: Blake's cyst (MM.org, [Chunk 4](#), 9/11/20)
- tells Sara on 6/1/20 that he's just talked to his surgeon "in the east" and no date has been set yet for his GRS; later says he's unsure what organs he will get via GRS but expects labia, clitoris, vagina, and cervix, says he doesn't "know what their plan is" for ovaries and shelves the discussion when Sara says she doesn't think ovaries can be transplanted (MM.org, [Chunk 1](#), 9/11/20)
- says his surgeon wants him to have a "vaginal vaccination" (HPV vaccination) to prevent future problems (MeowMix [archive](#), 4/19/20)
- tells Emily Tressa that she helped him get through GRS (MeowMix [archive](#), 4/17/20) and soon thereafter tells a 16-year-old on Snapchat that he'd like to "stick my meat in" after removing her tampon and had a dream that the "pussy fairy" had given him the "coin slot pussy" he desires (MeowMix [archive](#), 4/19/20)
- **has gender dysphoria?**
 - Rebel Media wrongly reports that, at the stun gun sentencing, the judge said the court-ordered psych eval determined Yaniv has [borderline personality disorder](#) and [gender dysphoria](#) (KF post [18.503](#), 9/22/20)
 - tells Sara on 8/30/20 regarding past comments about teens, "I'm female. I suffer from significant gender dysphoria and I went through a hard phase." (MM.org, [Chunk 10](#), 9/20/20)
 - on 7/20/20, he repeated the same thoughts, texting Sara that he wants his penis removed and "I'm extremely gender dysphoric." (MM.org, [Chunk 4](#), 9/11/20)
 - says "My gender dysphoria is extremely bad. That's why I really want my surgery. I want actual boobs, Not these stupid lump things. I mean they're growing but I look like a 12 year old with boobs" (p. 137, [MM chat log](#); KF [thread](#), 11/26/19)
 - wants the "ability to put things inside of it and that that ill actually be considered a girl fully physically" (p. 139, [MM chat log](#); KF [thread](#), 11/26/19)

- says he's "super gender dysphoric" and can't see himself with male parts so he tells people they're already gone (p. 155); "I want the thingy gone" (p. 184, [MM chat log](#); KF [thread](#), 11/26/19)
- "I want my pussy so bad" (p.186, [MM chat log](#); KF [thread](#), 11/26/19)
- DMs surface in which Yaniv claims he has ovaries and possibly an inactive uterus, a condition his aunt has; also says he's "super gender dysphoric" and can't see himself with male parts (KF post [171](#), 11/21/19)
- states repeatedly that he has gender dysphoria (which DSM-5 does not categorize as a personality disorder, but IDC does) and anxiety (example, [archived tweet](#), 5/25/19)
- **does not have gender dysphoria?**
 - tells Sara she can refer to his penis as his "cock," have penis-in-vagina sex with him, say "cum in me" and "do me harder Jessica," and he wants to cum on her face, belly, and breasts, all of which would indicate he does not have gender dysphoria (MM.org, [Chunk 6](#), 9/17/20)
 - tells a 16-year-old on Snapchat that he wants to "stick my meat in" after removing her tampon but also that he dreamed the "pussy fairy" had given him the "coin slot pussy" he desires (MeowMix [archive](#), 4/19/20)
 - in 2014, he messages a 14-year-old girl asking for pictures of her tampons and pads, says he envied her having cramps, he prefers to have sex with girls under 18 because their vaginas are tighter (KF post [270](#));
- attended a meeting with other candidates for bottom surgery at Vancouver General Hospital in September 2019 (KF [thread](#), 11/17/19; KF [thread](#), 11/26/19); pondering dilation (KF post [14,787](#), 11/21/19)
- went for a surgery assessment on 10/30/19, telling MandaPanda that he didn't want Miriam to go with him because "She will try to stop it" (pp. 131, 141, and 147); doctor tells him he will be able to pee sitting down, which Yaniv says he's done for years; misunderstands dilation instructions (p. 148, [MM chat log](#); KF [thread](#), 11/26/19)
- BCHRT decision: "I am satisfied, based on Ms. Yaniv's representations to the Respondents that she ... has not "gone through surgery yet" ([JCCE](#), p 10, para 22, 10/22/19)
- says he has GRS scheduled, when asked when the surgery is to be done he refuses to say and then says it has not been scheduled ([notes](#), 7/17/19)
- objects to Galaxy Pageants requiring that he have GRS before competing ([KF post](#), 6/2/19)
- implies but refuses to clarify that the cramps and discharge referred to in the section above are the results of GRS ([KF post](#), 5/26/19)
- responds to a doubter with "And you know that.. how? How about I throw my dilation [sic] dildo at your face then" ([KF post](#), 5/26/19)

Hormone Use

- tells Sara on 9/4/20, "I feel I'm Going to throw up. I got my injection and I feel nauseated"; "I feel like I'm going to faint. I called ambulance"; "I feel woozy cause of my hormone injection, doctor I talked to told me to call 911 NOW," "I think my blood sugar is low" (MM.org, [Chunk 11](#), 9/20/20); neighbor observed paramedics being buzzed in and Miriam arriving with a box of iced tea; paramedics leave without Yaniv ([tweet](#); [archived tweet](#)); tells Sara the paramedics couldn't tell what was wrong, his doctor sent him for blood tests, doctor said it might have been a "hormonal blip" (MM.org, [Chunk 11](#), 9/20/20)

- tells Sara on 8/11/20 he's going to the doctor for a hormone shot ((MM.org, [Chunk 7](#), 9/17/20)
- tells Sara on 7/20/20 that hormone treatments have left him unable to maintain an erection and "I took hormone blockers that stopped my Testosterone building up. So that means, I don't produce sperm, so I can't come. I used to be about 5.5 inches, but hormones do affect ghat so it's maybe 3 now, or 4." (MM.org, [Chunk 4](#), 9/11/20)
- tells Sara on 6/1/20 that he's "on a huge amount of hormones" and frequently refers to injecting himself with them and their effects (MM.org, [Chunks 1 & 2](#), 9/11/20)
- tells Nicole "these hormones are making me super horny constantly" (MM.org, [Nicole23](#), 4/10/20)
- tweets on 1/8/20 that he's taken more than \$1,000 of doctor-prescribed hormones (KF post [15.761](#), 2/11/20)
- takes estrogen, according to Katie (KF [thread](#), 11/17/19); tells online doctor he's been taking estradiol, spironolactone, and metformin since July 2018 ([CoR](#), 4/9/19)
- says on 11/15 that HRT is going all right, "My boobs are growing quickly" (p. 201, [MM chat log](#); KF [thread](#), 11/26/19)
- says 10/19/19 marks one year of being on hormones (p. 92, [MM chat log](#); KF [thread](#), 11/26/19)
- tweets about estrogen's effect on smooth muscle tissue giving trannies cramps ([KF post](#), 10/13/19)
- says he had hormone injections on 10/1/19, having "serious PMS" as a result; on 10/15, so his boobs hurt (p. 82); on 11/9 (along with vitamins and inoculations for polio, tetanus, and hepatitis B) (p. 216); on 11/19 (p. 217-18) ([MM chat log](#); KF [thread](#), 11/26/19)
- holds up meds packet during a stream with Blaire White labeled as Estradiol 2mg and three OTC nutritional supplements: Alpha lipoic acid 100mg, CoQ10 100mg, and Magnesium 50mg (KF post [401](#), [screen shot](#), 8/5/19)
- tweets that he is taking progesterone and estradiol, which are causing "insane hotflashes" ([archived tweets](#), 6/28/19)
- says he's taking HRT and "breast growth" hormones ([KF post](#), 6/4/19)
- says he's taking hormones that make him volatile ([KF post](#), 5/28/19; [KF post](#), 4/29/19; [KF post](#), 5/27/19)
- tells online doctor he felt overheated and sweated profusely when drinking hot chocolate; has happened in the past; taking estradiol 2mg twice a day and spironolactone 100mg twice a day along with metformin and Biaxin, TSH in the 1-2 range; told sweating is a completely normal response to drinking hot liquids but also could be related to the meds ([CoR](#), 3/25/19)

Sexual Conduct

- texts Sara on 9/5/20 that he lied about having had sex with a girl in a Kwantlen restroom and with a prostitute because he didn't want to be "known as a 21 year old virgin back then"; says he remains a virgin; the girl he posted a pic of kissing his cheek was Megan, they had had Skype "sleepovers," sleeping with their laptops watching each other sleep (MM.org, [Chunk 11](#), 9/20/20; MM.org document library chatlogs: sex in washroom stroy, MandaPanda pp 43, 160-61, of the single-column transcript; "Emma" MSN transcript, pp 3-4)
- texts Sara on 9/5/20 that he kissed a girl named Rachel Bennett in April 2020, they made out but they weren't compatible, it was a one-day thing, she blocked him the next day (MM.org, [Chunk 11](#), 9/20/20); Rachel told MM.org she felt compelled to let him in though he was so different from his shopped profile

pic and let him kiss her rather than fight someone so much bigger than she was (MM.org, [Rachel](#), 10/21/20)

- texts Sara on 9/3/20, “It was really hard through my pre teens not going through female puberty. So that’s where really wanting to get my period and putting my mind into it really got to” (MM.org, [Chunk 10](#), 9/20/20)
- texts Sara on 9/3/20, “I’m not a MAP. But I do need therapy.” Asked what problems the therapy would address, he replied “I have encountered so much trauma. I need anxiety, PTSD and depression counseling. I can’t even concentrate anymore”(MM.org, [Chunk 10](#), 9/20/20)
- texts Sara on 8/24/20 that since the sexual assault he invented in which Amy Hamm somehow took pictures of his genitals from an adjacent restroom stall she never entered, he’s unable to “even look t myself the same way and when I see pictures of that, it hurts me” [meaning his genitals]; she had sent him nudes at his request and he refused to return the gesture (MM.org, [Chunk 9](#), 9/20/20)
- while masturbating on 8/11/20, he texts Sara that he would like her to breastfeed him (MM.org, [Chunk 7](#), 9/17/20)
- posts video of himself and his mother at a Sooke, BC, hotel pool showing Miriam in a black lace bra fondling and kissing him in a sexualized manner (MM.org [article](#), 7/26/20; real location verified, MM.org [article](#), 7/26/20)
- @mamathirteen (Theresa Kelly) says on Twitter that Yaniv once tricked a co-op student staffer at a Langley women’s shelter into putting a Poise pad in his underpants (KF post [3,340](#), 1/2/20; MeowMix’s “Jenny” story, [archive](#), 1/14/20); doubts raised about this report’s credibility
- accuses journalist Amy Hamm of sexual assault in the form of voyeurism on 1/13/20 (KF [thread](#), 1/116/20), days later, after being arrested for hitting journalist Kean Bexte, Yaniv takes an ambulance to a sexual assault shelter (KF post [46](#), 1/16/20); she sues him for defamation (KF post [239](#), 2/10/20); he responds (KF [285](#), 3/9/20)
- claims an employer exposed his penis and told Yaniv to suck it; Yaniv replied that customers would see them and the incident ended; he continued to list the man as a client into 2019 (p. 169, MandaPanda transcript, KF [thread](#), 11/26/19; MeowMix [archive](#))
- tweets that he was sexually assaulted at some point and now suffers flashbacks during which he chokes on vomit (KF [thread](#), 8/20/19); on the same day he tells an online doctor he can’t talk during a scheduled appointment because he’s dining in a restaurant ([CoR](#), 8/20/19)
- texts Nicole that he’s told his producer (Ryan Gordon) that he wasn’t doing the movie deal because he’d told the producer about being raped while in college and “couldn’t continue talking about these things”; by rape does he mean when other boys shoved their way into a stall and groped him? (MM.org, [Nicole102](#), 8/19/19)
- on 4/22/19 says he’s disappointed because the women in the changing room of the gym he just joined don’t have their “boobs out”; joined because he believes he won’t have to work out near Asian immigrants there ([QP](#))
- tweets on 4/19/19 that he’s “been assaulted several times in a bathroom” (MeowMix [archive](#))
- asked online doctor to be screened for sexually transmitted diseases because although he hasn’t been sexually active in the past five years and rarely was before that, he wouldn’t want to be a carrier; got referral for testing ([CoR](#), 4/12/19)

- in 2018 blames his perving on his father's death and an American paramedic he says pushed him into discussing girls needing help with menstrual pads; blames his racism on having been sexually assaulted and harassed by immigrants ([KF post](#), 12/12/19)
- on 5/27/18 asks a different girl if he should face members of a girls' swim team while he's changing, wants to bond with them, they "literally get down to their pussy and boobs out and don't mind at all, them and their friends" (MeowMix [archive](#))
- messages 13-year-old Riley on 5/26/18 about being in a change room where "girls your age" are getting naked "and smiling at me while I change as well? ... Do you think they're comfortable with me and see me as a girl?"; asks whether he should turn around from his locker to face them to "bond" with them; sent pic of himself wearing boxers with an erection and another of the tip of his penis (MeowMix [archive](#))
- says 2015 was his last sexual encounter, it was with a hooker and it was "fun" (p. 101-02, [MM chat log](#); [KF thread](#), 11/26/19); in 2019, he tells an online doctor that his last sexual activity was five years previous, which fits with his earlier remark about the hooker ([CoR](#), 4/27/19)
- in 2015 an employer exposed his penis and told Yaniv to suck it; Yaniv instead warned him customers could see them (pp. 167-68, [MM chat log](#); [KF thread](#), 11/26/19); as of 2020, Yaniv was still listing that employer among his clients
- in 2014 he repeatedly messages a woman asking for instructions on how to haunt women's washrooms, says he fears being spied on in men's washrooms, wants help buying a woman's bathing suit to wear at a Las Vegas hotel, says he wants to date her, says he wants to marry her, says she makes his "wee wee go boing," says he wants to wear her prom dresses to pretend he is her, and says he wants her bras as well. ([KF thread](#), [transcripts](#))
- in 2014, he messages a 14-year-old girl asking for pictures of her tampons and pads, says he envied her having cramps, he prefers to have sex with girls under 18 because their vaginas are tighter, sends her smutty recordings in a Tickle Me Elmo voice and singing "Tampon Man" in a Barney voice, says he uses Google Glass to watch porn while he's walking through a mall ([KF post 270](#)); says he wants her to be his girlfriend, eventually asks her to marry him; knowing that she's just started high school, he offers to buy her a plane ticket so that she can visit him; she learns he was sending other girls similar content and some had fallen for it; said he'd been messaging one girl since she was 10 ([KF post 121](#))
- at the 2012 Consumer Electronics Show in Las Vegas, Yaniv arranged to share a room with a Gizmofusion colleague who complained that he repeatedly approached her sexually, ignored her requests that he stop. Among his asks: that she urinate on him. She eventually slapped him after he grabbed her face forcefully (Post Millennial article, August 19, 2019, [thread](#); [archived](#)); in 2019, Yaniv told MandaPanda that "a girl I took to a conference went on me and fucked the shit out of me" ([KF post 43](#), 11/30/19; [MM chat log](#), 10/28, pp. 139-40)
- he says in 2005, his first year at Kwantlen Polytechnic, two boys barged into a washroom stall and caught him changing his pad and groped his genitals; he reported it to security, but there was no evidence and nothing was done (MandaPanda p. 169, 2-col [MM chat log](#), or p. 267 of one-col transcript) MeowMix [archive](#), [KF thread](#), 11/26/19); tells the story in greater detail to Sara on 6/15/20 (MM.org, [Chunk 2](#), 9/11/20)

Legal Status

- says on 7/29/20 that he changed his name to Jessica Simpson the previous week; coy about the middle name he chose, saying, "My middle name stands for calm and peacefulness. Basically me in nutshell" (MM.org, [Chunk 5](#), 9/17/20)

- says he changed his name to Jessica Yaniv in 2019 (MM.org, [Chunk 5](#), 9/17/20)
- told Riley he was changing in a locker room with a girls' swim team in May 2018 and, when asked if they accepted him there, said yes (MM.org, Riley's gallery, 5/26-30/18)
- claims he transitioned legally in 2017 (see the court filing in MM.org [article](#), 8/27/20)

Awaiting Clarification

- texts Sara, "I pushed myself too hard yesterday cleaning. I need to remember that I can't do that my body can't and as much as I think I can fight my disability I can't"; (unclear what this disability is (MM.org, [Chunk 11](#), 9/20/20)
- texts Sara on 8/23/20, "The new meds I'm on are making me feel so sick that I could fall asleep right now until 9 am tomorrow," but he may just be avoiding a discussion about nude pix he doesn't want to have; then says they're sleeping pills that leave him woozy during the day (MM.org, [Chunk 9](#), 9/20/20)
- texts Sara on the evening of 8/22/20, "I'm not feeling well today I think I caught something. I'm so loopy and drowsy like I spaced out" - she'd earlier been trying to discuss finances with him (MM.org, [Chunk 9](#), 9/20/20)
- texts Sara on 8/22/20 that he took a new medication and awoke well rested "which has never happened to me" (MM.org, [Chunk 8](#), 9/17/20)
- texts Sara on 8/12/20 that he's feeling dizzy (MM.org, [Chunk 7](#), 9/17/20)
- texts Sara on 7/26/20, "I have a lot of pain again. Just took some pain meds. Hopefully that helps." (MM.org, [Chunk 4](#), 9/11/20)
- Yaniv has been "certified as disabled by doctors licensed and registered in BC and the Government of Canada," according to a court filing Yaniv made in the Amy Hamm defamation case, type of disability not specified (MM [post](#), 8/24/20)
- ambulance at his strata, Miriam gets into it while he talks to the paramedics, he says he'll email them, Miriam gets out of the ambulance and walks with her son across the street to her strata ([tweet](#), [archived tweet](#)); he returns to yell in the parking lot about a neighbor's tweet and says on Snapchat that the ambulance was there because of a bomb threat ([tweet](#), [archived tweet](#))
- ambulance observed at Yaniv's strata (KF post [4,605](#), 4/26/20)
- ambulance observed at Yaniv's strata, but it left without him (KF posts [4,447](#) and [4,448](#), 4/9/20)
- told a judge he will be out of BC for surgical consultation, Apr. 6-11, 2020; did not disclose the surgical issue (3/16/20, [archive](#)); trip rendered impossible by COVID-19 lockdown
- ambulance observed at Yaniv's strata (KF post [15,455](#), 1/20/29)
- ambulance at Yaniv's condo - he talks to the paramedics from his balcony, triggered medic alert alarm (KF post [15,126](#), [15,129](#), 12/16/19); thanks RCMP for rescuing him by climbing up the outside of his building to get to him (KF post [15,140](#), [15,143](#) (pix), 12/17/19)
- tweets picture of hospital meal tray and ticket showing it's in Langley Memorial Hospital's acute care unit but the picture appears to have been taken in a hallway (KF post [15,154](#), 12/17/19)
- seen climbing into the back of an ambulance (KF post [2,910](#), 12/12/19)

- tweets he's in the hospital, angry at Fraser Health for not being seen despite referral from the ER (KF posts [2,702](#), [2,703](#), 12/2/19); next day tweets about a gynecologist refusing to see him because he's trans - not clear if he sought an appointment because of a referral from the ER the previous day (KF post [2,713](#), 12/3/19)
- tweets that Miriam stays at his place to ensure he gets proper medical care when "I'm sick, fainting and I stop breathing" (KF post [144](#), 10/10/19)
- tells MandaPanda on 10/4 that he's at the hospital for tests "cuz im sick" and that he has to stay overnight (pp. 41-42, [transcript](#), [KF thread](#), 11/26/19)
- neighbor hears Yaniv yelling at his mother on 8/8/19 about some redecorating they were doing in his strata; ambulance arrives and leaves without Yaniv, EMTs complain about their time having been wasted as they leave (WGKitty Q&A [archive](#), 12/20/19)
- seen being taken away from his strata complex by ambulance, no lights or siren (KF post [34](#), 8/5/19) - this is the day of the Blaire White stream during which he displayed an illegal stun gun and ended up being arrested
- Miriam (or Jonathan pretending to be Miriam) tells a Facebook group Jonathan is in the hospital "right now not doing so well" ([KF post](#), 7/21/19) - this is the day after Yaniv was in an ER after being hit in the face by a 60+ woman in a parkade confrontation
- posted pictures of his feet against the doors of an ambulance on Facebook, saying, "My dog is dying and I'm an emotional wreck. Life has been horrible to me lately. I don't know how much more I can take on top of these major unsolvable health issues"; neighbor observed no ambulance at Yaniv's strata building that night ([KF post](#), 7/14/19); online doctor may have been referring to this as "whole body twitching" but no loss of consciousness incident on 7/13, high blood sugar consistent with type 2 diabetes ([CoR](#), 7/15/19)
- in a 7/10/19 Facebook video, he's back in the hospital because of "episode after episode after episode"; as of 1 a.m. he had not been seen by a doctor ([KF post](#), 7/11/19); the following day he tweets, "They keep discharging me and loads of outpatient tests" ([Twitter archive](#), 7/12/19) - he had lots going on at that point, see the timeline pdf for details
- tweets that he's leaving in an ambulance, but WGKitty says the ambulance was called for an older resident of the strata (WGKitty Q&A [archive](#), 12/20/19)
- mother disrupts tribunal hearing because she believes he is ill and has ambulance called, EMTs speak with Yaniv and leave while Yaniv stays in the hearing until its conclusion ([KF post](#), 7/5/19)
- in the 9 or so weeks that he exchanged messages with MandaPanda, he told her he felt sick on more than 11 occasions and that he had fainted on 5 ([transcript](#), [KF thread](#), 11/26/19)
